ORDINANCE

APPROVING CONTRACTS FOR FORKLIFTS AND MAN LIFTS WITH BRIGGS INDUSTRIAL SOLUTIONS, INC., DBA BRIGGS EQUIPMENT, FOR \$127,833.00, ASSOCIATED SUPPLY COMPANY INC., DBA ASCO EQUIPMENT, FOR \$28,900.00, AND OCTANE FORKLIFTS, INC., FOR \$35,061.00, FOR THE TOTAL COST OF \$191,794.00 FOR ALL CONTRACTS. FUNDING IS FROM THE HOTEL OCCUPANCY TAX FUND IN THE AMOUNT OF \$170,814.00, AND FROM THE GENERAL FUND FOR \$20,980.00.

WHEREAS, bids were submitted to provide the City of San Antonio with forklifts and man lifts; and

WHEREAS, the alternate bid submitted by Briggs Industrial Solutions, Inc., dba Briggs Equipment, for item 3 failed to meet the City's specifications and/or requirements for forklifts; and

WHEREAS, the bids submitted by Associated Supply Company Inc., dba ASCO Equipment, Octane Forklifts, Inc., and Crown Equipment Corporation for item 4 failed to meet the City's specifications and/or requirements for forklifts; and

WHEREAS, the low responsive bid for items 4 and 5 was submitted by Briggs Industrial Solutions, Inc., dba Briggs Equipment, for a total cost of \$127,833.00; the low responsive bid for item 1 was submitted by Associated Supply Company Inc., dba ASCO Equipment, for \$28,900.00; and the low responsive bid for item 3 was submitted by Octane Forklifts, Inc., for \$35,061.00;
NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The bids submitted by Briggs Industrial Solutions, Inc., dba Briggs Equipment, (Items 4 and 5) for a total cost of \$127,833.00, Associated Supply Company Inc., dba ASCO Equipment, (Item 1) for \$28,900.00, and Octane Forklifts, Inc., (Item 3) for \$35,061.00 are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. Attached hereto and incorporated herein for all purposes as **Exhibit I** is a copy of the bid tabulation sheet.

SECTION 2. It has been found and declared that the alternate bid submitted by Briggs Industrial Solutions, Inc., dba Briggs Equipment, for item 3 and the bids submitted by Associated Supply Company Inc., dba ASCO Equipment, Octane Forklifts, Inc., and Crown Equipment Corporation for item 4 failed to meet the City's specifications and/or requirements for forklifts.

SECTION 6. Payment is authorized to Associated Supply Company Inc., dba ASCO Equipment, and should be encumbered with a purchase order.

SECTION 7. Funding for this ordinance in the amount of \$35,061.00 is available in Fund 29007000, Cost Center 4229000022 and General Ledger 5709060 as part of the Fiscal Year 2025 Adopted Budget approved by City Council.

SECTION 8. Payment is authorized to Octane Forklifts, Inc., and should be encumbered with a purchase order.

SECTION 9. Funding for this ordinance in the amount of \$168,000.00 is available in Fund 47099000, Project 45-00087, WBS Element 45-00087-05-02-01 and GL Account 5501055.

SECTION 10. The financial allocations in this ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 11. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
