With reference to the captioned project, please be advised that the City of San Antonio has now completed the canvassing process and will recommend approval of your request subject to the following conditions:

**Parks:** Open space dedicated per Park Dedication Ordinance and is not maintained by the City of San Antonio Parks and Recreation Department. Homer Garcia (210) 207-8480

**PWD Environmental:** It is the Petitioner's responsibility to conduct their own due diligence for this area. The City does not warranty that environmental impacts are not to be encountered when disturbing the land. The City shall not bear any financial burden related to environmental impacts (if any) encountered during the disturbance of the land. **Right-of-Way:** Contact and confirm with all utilities that there are no conflicts. Frank Castillo (210) 837-1378

**Storm Water:** The subject area depicted in red on Exhibit A shall remain unobstructed at all times. No fences or improvements allowed. Saif Al Haddad (210) 843-3521

Per Municipal Code Chapter 37-14 there are no fees associated with releasing an easement on non-city owned property.

Petitioner is responsible for the Bexar County Clerk recordings fees. The amount will be determined prior to recording, and petitioner will provide a check for that amount payable to the Bexar County Clerk.
