ORDINANCE

**APPROVING AN AGREEMENT WITH RIGHTSITE
HEALTH PHYSICIANS PLLC FOR TELEMEDICINE AND
OTHER SERVICES TO SAN ANTONIO FIRE
DEPARTMENT MOBILE INTEGRATED HEALTHCARE
PATIENTS FOR THE PERIOD THROUGH DECEMBER 31,
2027, WITH TWO ONE-YEAR RENEWALS AT CITY'S
OPTION. THE CITY WILL NOT INCUR ANY COST FOR
THESE SERVICES, WHICH WILL BE BILLED DIRECTLY
TO THE PATIENT'S INSURANCE PROVIDER.**

WHEREAS, in an effort to reduce Emergency Medical Service (EMS) utilization, particularly in non-emergency use and hospital emergency departments, the City issued a Request for Qualifications for San Antonio Fire Department (SAFD) telemedicine and patient navigation; and

WHEREAS, three responsive proposals were received, and the evaluation committee recommends RightSite Health Physicians PLLC (RightSite) for the award; and

WHEREAS, pursuant to this agreement RightSite would provide telemedicine and patient navigation service to be used to support operations by the SAFD Communications and EMS Divisions and provide enhanced care for low acuity medical patients; and

WHEREAS, the agreement will be for the period through December 31, 2027, with two one-year renewals at City's option, with no cost to the City in that costs will be billed directly to the patient's insurance provider; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The terms and conditions of a Professional Services Agreement with RightSite to provide Telemedicine and other services for the period through December 31, 2027, with two one-year renewals at City's option, are hereby approved and the City Manager or designee, or the Chief of the Fire Department or designee, is authorized to execute an Agreement that is substantively similar to the agreement that is attached hereto and incorporated herein for all purposes as **Exhibit A**. The City Manager or designee, or the Chief of the Fire Department or Designee, are also authorized to execute two one-year renewals without further action by City Council.

SECTION 2. There is no cost or fiscal impact to the City by this agreement; costs incurred by RightSite will be billed directly to the patient's insurance provider.

SECTION 3. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
