

# Amendment No. 3

This Amendment No. 3 is entered into by and between **City of San Antonio, TX ("City")**, and **Environmental Systems Research Institute, Inc. ("Esri")**, and is effective as of October 19, 2024 ("Amendment No. 3 Effective Date").

WHEREAS, Esri and City entered into an Enterprise Agreement with an effective date of October 19, 2018 (hereinafter "EA" or "Agreement"); and

WHEREAS, the parties desire to amend the Agreement to extend the term for an additional two (2) months from October 19, 2024, through December 18, 2024 and update applicable language and appendices;

NOW THEREFORE, the parties agree to the following:

1. Article 7.1 Term. The term of this Agreement is extended for an additional two (2) months from October 19, 2024, through December 18, 2024, unless this Agreement is terminated earlier as provided therein.
2. Delete and replace Appendix B EA Fee Schedule with the attached Appendix B EA Fee Schedule, which shall supersede and apply on the Amendment No. 3 Effective Date.
