Brief Description of Item(s) and Use: <p>This contract will provide the San Antonio Police Department (SAPD) with two on-call service providers to service vehicles with emergency equipment which include but are not limited to the following services: (A) providing vehicle graphic kits, (B) installation, removal, and repair of police vehicle equipment, and (C) providing emergency equipment parts. The vehicle graphics and emergency equipment parts will be placed on all Police Department marked emergency vehicles for the purpose of identification. The contract shall include the purchase of inventory and noninventory parts and may utilize parts and items the City may have in stock from another party/supplier.</p> <p>This purchase was made utilizing a public health or safety exemption to allow for multiple vendor awards. Vendors will provide installation and removal of emergency equipment on SAPD vehicles. Awarding to multiple vendors will assist with avoiding delays for services from just one vendor.</p>
