

ORDINANCE 2022-08-11-0576

AWARDING THE 2022-2023 TASK ORDER CONTRACT FOR TRENCHLESS CORRUGATED METAL PIPE (CMP) REHABILITATION TO LEWIS CONCRETE RESTORATION CORPORATION IN THE AMOUNT OF \$3,954,514.44, A STORM WATER OPERATING FUNDED PROJECT, LOCATED CITYWIDE. FUNDS IN THE AMOUNT OF \$2,000,000.00 ARE AVAILABLE FROM THE STORM WATER OPERATING FUND AND INCLUDED IN THE FY 2022 - FY 2027 CAPITAL IMPROVEMENT PROGRAM. THE REMAINING AMOUNT OF \$1,954,514.44 IS CONTINGENT UPON CITY COUNCIL APPROVAL OF THE FY 2023 BUDGET.

WHEREAS, as part of the FY 2022 Adopted Budget City Council approved \$2 million for Corrugated Metal Pipe (CMP) Rehabilitation Program; and

WHEREAS, the proposed two-year contract will rehabilitate approximately 8,000 feet of CMP; and

WHEREAS, funding in the amount of \$2,000,000.00 for the first year of this contract is available from the FY 2022 CMP project funded through the Stormwater Operating Fund and the remaining amount of \$1,954,514.44 is contingent on the City Council's approval of the FY 2023 annual budget; and

WHEREAS, the 2022-2023 Task Order Contract for Trenchless Corrugated Metal Pipe (CMP) Rehabilitation Task Order Contract was advertised on April 22, 2022 and four (4) bids were received and opened on May 24, 2022 with Lewis Concrete Restoration Corporation submitting the lowest responsive bid; and

WHEREAS, this contract is within the scope of the Small Business Economic Development Advocacy (SBEDA) Program but due to a lack of available firms and/or subcontracting opportunities, the Goal Setting Committee was unable to apply a SBEDA tool to this contract; and

WHEREAS, construction is anticipated to begin in August 2022 and is estimated to be completed by September 2024; and

WHEREAS, this ordinance accepts lowest responsive bid and awards the 2022-2023 Task Order Contract for Trenchless Corrugated Metal Pipe (CMP) Rehabilitation project to Lewis Concrete Restoration Corporation in the amount of \$3,954,514.44 located citywide; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, or the Director of the Public Works Department or designee, is authorized to approve a task order contract to Lewis Concrete Restoration Corporation in the amount of \$3,954,514.44, for the 2022-2023 Task Order Contract for Trenchless Corrugated Metal Pipe (CMP) Rehabilitation located citywide. Funds in the amount of \$2,000,000 are available from the Storm Water Operating Fund and included in the FY 2022 - FY 2027 Capital Improvement Program. The remaining amount of \$1,954,514.44 is contingent upon City Council approval of the FY 2023 Budget.


SECTION 2. Funding for this will be identified when work orders are issued. If funding for any work orders is not previously appropriated, funding will be identified and appropriated through subsequent City Council action. Payment is limited to the amounts budgeted in the Operating, Grants, and/or Capital Budget funding sources identified. All expenditures will comply with Operating, Grants, and/or Capital Budgets for current and future fiscal years.

SECTION 3. Payment not to exceed \$3,954,514.44 is authorized to be encumbered with purchase orders and made payable to Lewis Concrete Restoration Corporation for trenchless corrugated metal pipe (CMP) rehabilitation citywide.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


