This Amendment No. 4 is entered into by and between **City of San Antonio, TX ("City")**, and **Environmental Systems Research Institute, Inc. ("Esri")**, and is effective as of December 19, 2024 ("Amendment No. 4 Effective Date").

WHEREAS, Esri and City entered into an Enterprise Agreement with an effective date of October 19, 2018 (hereinafter "EA" or "Agreement"); and

WHEREAS, the parties extended the Agreement term for two (2) months through December 18, 2024; and

WHEREAS, the parties desire to amend the Agreement to extend the term for an additional two (2) months from December 19, 2024, through February 18, 2025 and update applicable language and appendices;

NOW THEREFORE, the parties agree to the following:

1. Article 7.1 Term. The term of this Agreement is extended for an additional two (2) months from December 19, 2024, through February 18, 2025, unless this Agreement is terminated earlier as provided therein.
2. Delete and replace Appendix B EA Fee Schedule with the attached Appendix B EA Fee Schedule, which shall supersede and apply on the Amendment No. 4 Effective Date.

Except as may be specifically modified by this Amendment No. 4, all other terms and conditions of the Agreement and any Amendment(s) or Addendum(s) constitute the entire agreement between the parties and supersede all prior and contemporaneous agreements or representations, written or oral, concerning the subject matter of this Agreement.
