**SUBJECT:**

Interlocal Agreement: Right of Entry to Install and Maintain Regulatory School Zone Within City of San Antonio Limits (City of Leon Valley)

**SUMMARY:**

An ordinance approving the execution of an Interlocal Agreement between the City of Leon Valley and the City of San Antonio to grant the City of Leon Valley right-of-entry permission to install, maintain, inspect, repair, and replace infrastructure, including additional supplemental signage related to the Leon Valley school zone located within the City of San Antonio's limits.

**BACKGROUND INFORMATION:**

The City of Leon Valley wants to establish a reduced-speed school zone on Huebner Road at Redbird Lane. This school zone would assist students walking to John Marshall High School who live south of Huebner Road. While the actual crossing of Huebner Road will be within the City of Leon Valley, the limits of the school zone will extend into the City of San Antonio.

The proposed Interlocal Agreement (ILA) allows the City of Leon Valley or contractors to install, perform maintenance, repair, or replace infrastructure related to the school zone to potentially include flashing beacons mounted on mast arms and ground-mounted signage located at Redbird

Lane within the right-of-way of the City of San Antonio to alert drivers of potential pedestrians in the roadway.

**ISSUE:**

This ordinance approves the execution of an Interlocal Agreement between the City of Leon Valley and the City of San Antonio to grant the City of Leon Valley right-of-entry permission to install, maintain, inspect, repair, and replace infrastructure, including additional supplemental signage related to the Leon Valley school zone located within the City of San Antonio's limits.

On January 17, 2023, the Leon Valley City Council approved a city ordinance establishing a school zone on Huebner at Redbird Lane. The City of Leon Valley will install and maintain the school zone at the intersection of Huebner at Redbird Lane to facilitate a safe road crossing for John Marshall High School students.

The school zone will help alert drivers of potential pedestrians in the roadway. An agreement is required to grant the City of Leon Valley right-of-entry permission to complete this recommended safety measure. Upon approval, the City of Leon Valley will complete the installation by Fall 2023.

**ALTERNATIVES:**

Alternatively, the City Council could choose not to approve the Interlocal Agreement; however, the City of San Antonio would lose the opportunity to provide additional safety measures for residents living in the City of San Antonio and the City of Leon Valley.

**FISCAL IMPACT:**

There is no fiscal impact related to this agreement. This action allows the City of Leon Valley to install and maintain a school zone within the City of San Antonio limits.

**RECOMMENDATION:**

Staff recommends approval of the execution of an Interlocal Agreement between the City of Leon Valley and the City of San Antonio to grant the City of Leon Valley right-of-entry permission to install, maintain, inspect, repair, and replace infrastructure, including additional supplemental signage related to the Leon Valley school zone located within the City of San Antonio's limits.
