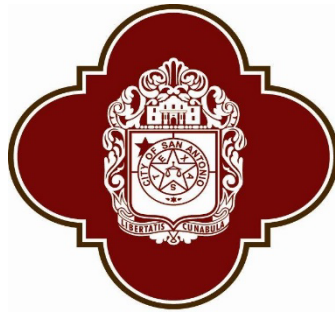

SUBJECT:

Consideration of 1 At-Large appointment to the Building Standards Board.

SUMMARY:

The Planning & Community Development Council Committee will review and consider applicants for 1 At-Large board seat to the Building Standards Board. Appointee will serve a term of office to begin upon approval by the City Council and to expire on May 31, 2025.

BACKGROUND INFORMATION:

The Building Standards Board (BSB) is a citizen-based board and has 10 members appointed by City Council members appointing their own representative to the board and 4 additional at-large appointees. The board composition is comprised of the following categories: Architect, Engineer, General Contractor, Social Worker, Health Care Professional, Retired individual (over the age of 64) and Veteran of the United States Military. A professional property manager may be substituted for one general contractor and/or one social worker. Members serve overlapping two-year terms and with no limit on the number of terms that may be served.

The City issued a board recruitment promotion release for openings for the BSB on October 6, 2023, through November 3, 2023, and on April 22, 2024, through May 3, 2024. The advertisements were placed on the City's website, City's social media sites, and TVSA. The Office of the City Clerk continuously accepts applications for the BSB.

The City received a total of 17 applications for the 1 available At-Large seat. A shortlist of 9 vetted and qualified applicants was provided to the Office of the City Clerk for scheduling interviews at the May 20, 2024, meeting of the Planning & Community Development Council Committee.
