John Bachman, Kristin Nickell, Robert Ramos requested that the City move to a no-kill animal shelter and recommended changes at Animal Care Services (ACS). Lea LaPorte and Michael Kucik spoke in support of funding to help with pet deposits. Michael Kucik requested goals and metrics in the new ACS Director contract.

Henrietta LaGrange recommended improved street marking/reflections on Broadway and to trim the medians. She stated that someone was trimming the grass in the median and a rock hit and broke her windshield.

Carl Merkle requested \$12,000 from the City and CPS Energy which he claims was stolen; stated that he had been kidnapped and was a victim of organized crime. Merke submitted a written statement.

Joshua Hinson asked for a public declaration that sidewalk chalk was legal. Michael Kucik spoke in support of Hinson.

Emily Joy Garza requested Public Comment Sessions to be live-streamed and recorded.

Martha Huerta requested help getting her son out of the Bexar County Jail where he had been detained since March 10, 2024. Huerta submitted a written statement.

Nikolaj (Nik) Zbilowski listed grievances against the Bexar County Jail and stated that he was denied access to his booking paperwork and other documents.
