ORDINANCE

APPROVING A TASK ORDER TO A JOB ORDER CONTRACT WITH CON-COR, INC., IN THE AMOUNT NOT TO EXCEED \$699,876.84 FOR THE CODY LIBRARY HVAC REPLACEMENT PROJECT, LOCATED IN COUNCIL DISTRICT 8. FUNDS ARE AVAILABLE FROM CERTIFICATES OF OBLIGATION INCLUDED IN THE FY 2025 CAPITAL BUDGET.

WHEREAS, the Bazan Library is located at Cody Library is located at 11441 Vance Jackson in Council District 8. This task order will provide for partial HVAC equipment replacement at Cody Library; and

WHEREAS, this proposed task order utilizes the Job Order Contracting Program (JOC) approved through Ordinance 2022-02-17-0107 by City Council on February 17, 2022. Using the JOC delivery method provides the City with on-call construction, renovation and maintenance services for City buildings and facilities. Of the eight contractors approved as part of the JOC, Con-Cor, Inc. has been selected; and

WHEREAS, this proposed task order includes engineering, equipment replacement, commissioning and testing and balancing. The equipment replacement will include 3 exterior Condenser Units, 3 interior Air Handlers, associated piping, ductwork, and electrical upgrades. Construction is anticipated to begin in Winter 2026 and is estimated to be completed by Spring 2026; and

WHEREAS, Con-Cor, Inc. has committed to meeting the Small Business Economic Development Advocacy (SBEDA) Program and the Goal Setting Committee recommendation of a 24% Minority/Women Business Enterprise (M/WBE) subcontracting goal and a 3% African American Business Enterprise (AABE) subcontracting goal; and

WHEREAS, this Ordinance approves a task order to a Job Order Contract with Con-Cor, Inc. in the amount of \$699,876.84 for the Cody Library HVAC project. Funds are available from Certificates of Obligation included in the FY 2025 Capital Budget; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, or the Director of the Public Works Department or designee, is authorized to issue a Task Order to the Job Order Contract with Con-Cor, Inc. in the amount of \$699,876.84 for the Cody Library HVAC project in Council District 8.

SECTION 2. Funds for this ordinance in the amount of \$699,876.84 is available in Fund 40099000, Project 23-04112, WBS Element 23-04112-05-02-01 and GL Account 5201140.

SECTION 3. Payment not to exceed \$699,876.84 is authorized to be encumbered with a purchase order and made payable to Con-Cor, Inc. Payment is in support for the Cody Library HVAC replacement project, located in Council District 8. Funds are available from Certificates of Obligation included in the FY 2025 Capital Budget.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
