

**AMENDMENT TO
PROFESSIONAL SERVICES AGREEMENT
FOR LANDSCAPE ARCHITECT SERVICES FOR
THE PERRIN HOMESTEAD HISTORIC CENTER PROJECT
NO.: 23-01696
AMENDMENT NO. 5**

This Amendment to the Professional Services Agreement for Landscape Architect Services for the Perrin Homestead Historic Center Project (“**Project**”), is entered into by and between the City of San Antonio (“**City**”), a home rule municipal corporation, acting by and through its City Manager, and RVK, Inc. (“**Consultant**”), acting by and through its duly authorized corporate representative, as set out below. The City and Consultant are referred to collectively herein as the “Parties”.

WHEREAS, on October 5, 2017 through Ordinance 2017-10-05-0742, City Council approved the execution of a Professional Services Agreement between the Parties for Professional Services for the Project; and

WHEREAS, September 21, 2018, the Parties executed a Professional Services Agreement in an amount not to exceed \$70,731.00 (“Original Agreement”).

WHEREAS, the Parties have previously amended the Original Agreement adding additional services and contract capacity of \$165,573.53, for a total current contract capacity of \$236,304.53; and

WHEREAS, the Parties desire to add additional Landscape Architect services and increase the contract capacity by \$77,745.00 to the Project, as described in the Fee Proposal and supporting sub-consultant proposals attached as **Exhibit 1**, and summarized in the table below:

Original Contract Capacity	\$70,731.00

WHEREAS, it is understood between the Parties that Exhibit 1 is attached solely for reference to the additional scope of services contained therein, and City is not bound by any additional terms or conditions contained therein nor in any attachments thereto; and

WHEREAS, the Contract Price is hereby revised to a not to exceed amount of \$314,049.53; and

NOW THEREFORE, in consideration of the terms, covenants, agreements and demises herein contained each to the other given, the sufficiency and receipt of which are hereby acknowledged, the Original Agreement is amended as follows:

1. **Contract Price.** The not to exceed amount of the Contract Price is hereby increased in the amount of \$77,745.00 for a revised not to exceed Contract Price of THREE HUNDRED FOURTEEN THOUSAND FORTY-NINE AND 53/100 U.S. DOLLARS (\$314,049.53).
2. **Additional Services.** The additional services described in the proposal letter attached as **Exhibit 1**, excluding any additional terms contained therein nor in any attachments thereto, are hereby added and incorporated into the Original Agreement.

Except as amended hereby, all other provisions of the Agreement and corresponding Amendments are hereby retained in their entirety and remain unchanged.
