ORDINANCE

APPROVING AN AMENDMENT TO THE CONTRACT WITH DAVID A MARKS, MD, PA, TO ADD ONE PSYCHIATRIC MENTAL HEALTH NURSE PRACTITIONER FOR THE SAN ANTONIO FIRE DEPARTMENT FOR A ONE-YEAR TERM COMMENCING JUNE 1, 2024 THROUGH MAY 31, 2025 FOR AN ADDITIONAL ESTIMATED AMOUNT OF \$142,826.00. THIS WOULD INCREASE THE TOTAL CONTRACT VALUE TO AN ESTIMATED \$1,790,826.00. FUNDING IN THE AMOUNT OF \$47,192.00 IS FROM THE GENERAL FUND FY 2024 ADOPTED BUDGET.

WHEREAS, pursuant to Ordinance No. 2023-09-14-0637, the City entered into a Professional Services Agreement with David A Marks, MD, PA, for medical oversight to the San Antonio Fire Department’s Health and Wellness Program for a term that began on September 15, 2023, and ends on September 30, 2026, with two additional, one-year options for the City to renew (the “Contract”); and

WHEREAS, the San Antonio Fire Department (SAFD) has had a psychologist on staff for over 35 years to address the behavioral health needs of its first responders; and

WHEREAS, due to the current absence of in-house professional behavioral health support resulting from the retirement of the staff psychologist, the City would like to amend the existing contract with David A. Marks, MD, PA, to add a full-time, on-site, psychiatric mental health nurse practitioner that would be available to SAFD leadership, personnel and family members for behavioral health needs; and

WHEREAS, approval of this ordinance authorizes an amendment to the contract with David A Marks, MD, PA, for a psychiatric mental health nurse practitioner for SAFD for a one-year term commencing June 1, 2024, through May 31, 2025, for an additional estimated amount of \$142,826.00; and

WHEREAS, all expenditures will be in accordance with the applicable fiscal year’s budget approved by City Council; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. This *First Amendment of the Professional Services Agreement for Wellness Medical Oversight and Staffing for the San Antonio Fire Department* between the City and

David A. Marks, MD, PA (the “Amendment”) is hereby approved in all things. A copy of the Amendment is attached hereto as **Exhibit I**. The City Manager or designee is hereby authorized to execute the Amendment on behalf of the City of San Antonio.

SECTION 2. Funding for this ordinance in the amount of \$70,720.00 is available in Fund 11001000, Cost Center 2015090001 and General Ledger 5201040 as part of the Fiscal Year 2024 Adopted Budget approved by City Council.

SECTION 3. Additional funding is contingent upon City Council approval of the Fiscal Year 2025 and subsequent budgets that fall within the term of the contract.

SECTION 4. Additional payment in the amount of \$142,826.00 is authorized to David A Marks, MD, PA and should be encumbered with a purchase order.

SECTION 5. The financial allocations in this ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 6. This ordinance is effective immediately upon passage by eight or more affirmative votes; otherwise, it is effective on the tenth day after passage.
