

METES AND BOUNDS DESCRIPTION
FOR A

A 143.537 acre tract of land being comprised of all of a called 141.0 acre tract and 2.537 acres out of a called 5.642 acre tract both being described in Deed Without Warranty to TF Cibolo Canyons LP recorded as Document Number 20200299549 in the Official Public Records of Bexar County, Texas, situated in the E. Martin Survey Number 89, Abstract 524, County Block 4909 of the City of San Antonio, Bexar County, Texas, the Francisco Valdez Survey Number 478 1/2, Abstract 787, County Block 4908 of the City of San Antonio, Bexar County, Texas, and the W.H. Huges Survey Number 478, Abstract 345 & 264, County Block 4906 of the City of San Antonio, Bexar County, Texas. Aforementioned tract being more particularly described below. Bearings reported herein are based on the Texas Coordinate System established for the South Central Zone from the North American Datum of 1983 NAD 83 (NA2011) epoch 2010.00; distances reported herein are surface US Survey Feet (Surface Adjustment Factor of 1.00017).

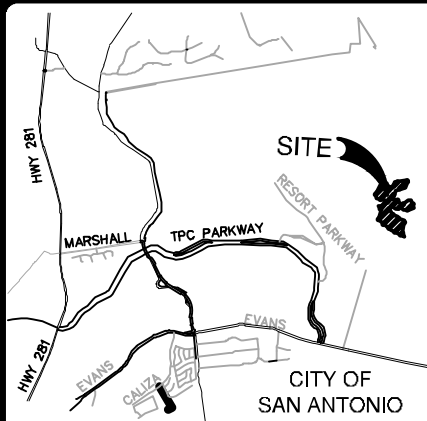

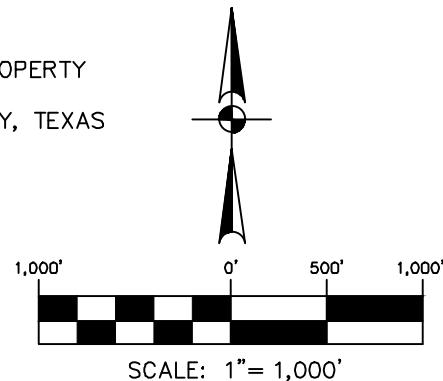


LOCATION MAP

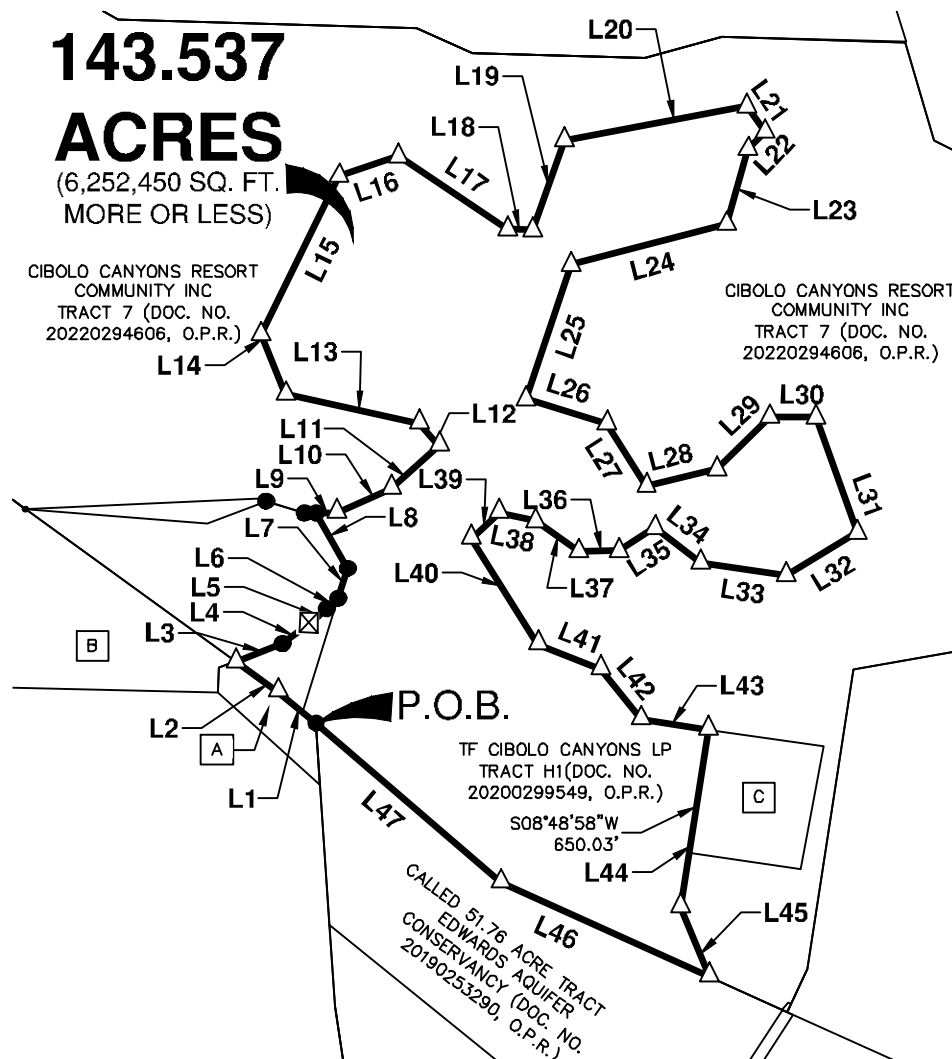

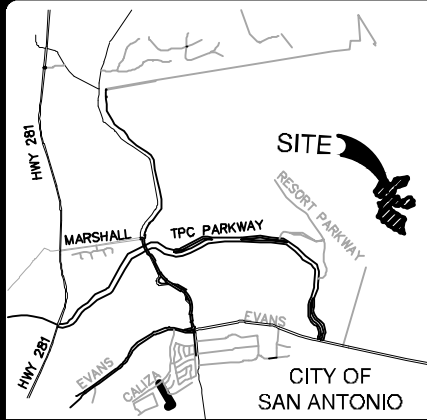

LOCATION MAP

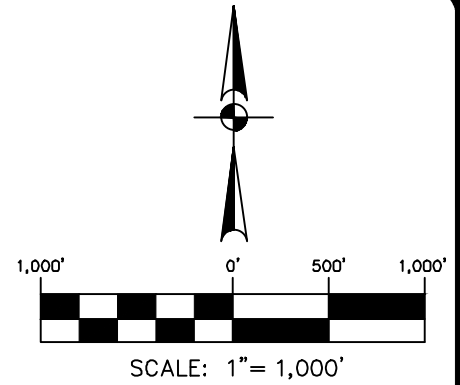
