**Whereas**, pursuant to Ordinance No. 2021-08-05-0509, the City of San Antonio and Parkeon, Inc., entered into a contract to provide the Center City Development Department (CCDO) with cloud-based maintenance, support services and replacement parts for existing on-street parking pay stations, which began on August 5, 2021 and, as renewed and extended ends on December 31, 2024 (hereinafter “the contract”);

**Whereas**, in February 2024, Parkeon, Inc. amended its registration with the Texas Secretary of State to change the legal name to Flowbird America Inc.;

**Whereas**, parties agree to amend the above referenced contract in accordance with RFO Section 006 – General Terms & Conditions, Amendments, to (a) extend the term for an additional one-year period for continued services beginning January 1, 2025, through December 31, 2025 for an annual total cost of \$65,412.00; and (b) add an additional one-year option for the City to renew, as follows:

#### 1. AMENDMENT

- 1.1. Section 005 – Supplemental Terms & Conditions, Original Contract Term and Renewals, is hereby revised to read:

Contract Term.

This contract began upon the effective date of the ordinance awarding the contract on August 5, 2021, and shall terminate on December 31, 2025.

Renewals.

At City's option, this Contract may be renewed under the same terms and conditions for one (1) additional one (1)-year period. Renewals shall be in writing and signed by Director, without further action by the San Antonio City Council, subject to and contingent upon appropriation of funding therefor.
