ORDINANCE

**A STREET MEMORIAL DESIGNATION REQUEST TO DESIGNATE A PORTION OF
“DOUGLAS WAY” TO “MONTGOMERY MEMORIAL WAY” LOCATED IN CITY
COUNCIL DISTRICT 2, SAN ANTONIO, TEXAS.**

WHEREAS, the City of San Antonio Development Services Department staff received a Street Name Change Application to designate a portion of “Douglas Way” to “Montgomery Memorial Way” between South Olive Street and South Pine Street; and

WHEREAS, staff began implementing this request through the street memorial designation process as required by Chapter 6 of the City Code; and

WHEREAS, staff conducted a technical review, finding the change to conform to City Code requirements for street memorial designation; and

WHEREAS, staff forwarded the request to all City of San Antonio departments and outside agencies for review and no opposition was identified

WHEREAS, staff properly posted and mailed notice of this memorial designation request to abutting property owners, and notice requirements for renaming of the street have been satisfied in accordance with Chapter 6 of the City Code; and

WHEREAS, a public meeting was held on June 25, 2024 allowing all interested persons to be heard, with no one in opposition; and

WHEREAS, the Planning Commission held a public hearing on July 10, 2024, allowing all interested persons to be heard, and recommended approval; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO;

SECTION 1. “Douglas Way” located in City Council District 2 between South Olive Street and South Pine Street is hereby designated “Montgomery Memorial Way”. All memorial designation requirements of Chapter 6 of the City Code have been met. The location of the street memorial designation is more specifically depicted in Attachment I. City Staff is directed to provide appropriate signage to this effect.

SECTION 2. (Financials to be provided)

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City

Manager or the City Manager’s designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBX Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance is effective immediately upon receipt of eight affirmative votes; otherwise, it is effective 10 days after passage.


