Approval of an appeal of the decision of the Board of Adjustment, pursuant to City Code Sec. 28-5, to deny a 163 square foot variance from the maximum 75 sign square footage to allow a 238 square foot digital sign, located at 5431 West Loop 1604. Approval of this item would allow the requested variance for the applicant. [John Peterek, Assistant City Manager; Michael Shannon, Director, Development Services]

Councilmember Courage pulled the Item from the Consent Agenda for Individual Consideration.

PUBLIC COMMENT:

Jack Finger spoke in opposition to the Item.

DISCUSSION:

Councilmember Courage commented that two City commissions both denied the variance and wondered why the Item was not recommended for denial. City Attorney, Andy Segovia, explained that the Item was on the Consent Agenda and therefore it needed to be voted upon in the

affirmative; a yes vote would be to accept the applicant's appeal and approve the variance. Segovia added that the Councilmember of that council district supported the variance to be approved. but he noted that in the future, an Item like this would be listed individually on the agenda with a recommendation in favor of the staff recommendation.

Councilmember Courage asked if he could make a motion to deny the appeal. Segovia advised that a motion to approve the appeal was already pending on the agenda, so if the City Council wanted to deny the appeal, they should vote "no" on the Item. Councilmember Courage noted that the corridor was the gateway to the Hill Country, and he did not support adding visual clutter. He also recommended supporting the work of the Board of Adjustment.

Councilmember Pelaez commented that a small, woman-owned business was being impacted by the Texas Department of Transportation (TXDOT) construction of an overpass at Loop 1604 and IH 10, and this was a compromise to reduce the size of an existing sign and allow it to be digital. He noted that another nearby sign of similar size had been given a variance but that it was not a small business and suggested that a double standard was being held.

Councilmember McKee-Rodriguez asked which boards had recommended denial. Assistant Director of the Development Services Department, Amin Tohmaz, stated that both staff and the Board of Adjustment recommended denial because the request was substantially larger than the sign code allowed. Councilmember McKee-Rodriguez asked why a non-digital sign was not proposed since it could be larger. The applicant responded that signage would not be a higher footprint than current, and a digital sign would provide better visibility for the business than a larger static sign.

Councilmember Viagran supported the appeal of the variance noting that with growth came changes to the City and she stressed the need to be flexible as the highway overpasses were completed; she did not want to hurt small businesses.

Councilmember Castillo noted that the Planning and Community Development Committee had a robust discussion about digital signage downtown which was fully supported by Councilmember Courage and she was disappointed that there was support for digital signs downtown but not on the North Side. Councilmember Castillo noted that as this was a small business, she supported the variance.

Councilmember Pelaez noted that there were no neighborhoods nearby and no community opposition to the variance had been received.

Councilmember Courage cautioned City Council against ignoring the recommendations of the City's volunteer board members and professional opinions of staff suggesting that it eroded public trust in the City Council. However, he acknowledged that the City Council had the right to make the final decision.

Councilmember Kaur commented that the job of City Council was to review each case individually and make the best decision for the community and not merely be a rubber- stamp for the staff.

Mayor Nirenberg commented that he did not know much about the issue until a constituent called with concerns. He had reviewed the Item's backup documents which recommended denial, however, he felt the discussion today was an enlightening conversation. Mayor Nirenberg noted that the overlay district was designed to protect the gateway to the hill country, but he recalled that a couple of years ago the policy was relaxed to allow more digital signs based upon growth. Tohmaz agreed that the area was mainly commercial, and stated that the City Code was adjusted in 2015 to allow for 25% digital signs in the area but this sign was larger than the City Code allowed so it resulted in staff denial.

Mayor Nirenberg recommended an update to the Ordinance as much had changed in the area since 2015. He supported the smaller sign that was digital rather than the larger static sign, which would be allowed under the current City Code.

City Manager Erik Walsh indicated that staff would ensure the corridor was reviewed for potential revisions to the City Code.
