Chef Johnny Hernandez, representing Host True Flavors introduced the Host Team: Chef Nicola Black, Chef Elizabeth Johnson, Chef Jason Dady, and Chef Alison Balfour spoke in support of the Item.

**DISCUSSION:**

Following the main motion to approve staff's recommendation made by Councilmember Kaur which was seconded by Councilmember Castillo, Councilmember Viagran moved to amend the main motion to direct Aviation Department staff to negotiate with Host True Flavors for a prime concession agreement for Food and Beverage Package 1 at San Antonio International Airport and return to Council for approval if an agreement was reached. If an agreement was not reached, then Staff was directed to issue a solicitation for a prime concession agreement for Food & Beverage Package 1. Councilmember Cabello Havrda seconded the motion.

Mayor Nirenberg recessed the meeting at 10:27 a.m. in order to convene the Special Session. Mayor Nirenberg reconvened the A Session meeting at 12:45 p.m. following Special Session and Discussion on Item 14 resumed. Items 22 and 27 were heard afterward.

Councilmember Cabello Havrda clarified that the amendment proposed by Councilmember Viagran was to approve the Item which was to approve a contract with Host for Food & Beverage Package 2 and Paradies Lagardere for Retail, but also direct staff to negotiate with Host for Food & Beverage Package 1 and if negotiations were not successful, issue a new Request for Proposals (RFP).

Councilmembers Rocha Garcia, Castillo, Alderete Gavito, Pelaez, Courage, and Whyte spoke in support of the local chef's participating at the airport as it would provide authenticity and a San Antonio experience for visitors at the San Antonio International Airport.

Councilmember Courage expressed concern that Host's proposal on Package 1 did not bring as much revenue to the City as Package 2 and recommended issuing the RFP for Package 2 as he felt this was a good old boys club.

Councilmember Pelaez clarified that the amendment was to grant the Airport Director authority to negotiate. Councilmember Kaur spoke in support of both the retail contract and to negotiate both food and beverage contracts with the Host team and stressed that if no agreement was reached, the City would issue an RFP.

Councilmember McKee-Rodriguez expressed that he was conflicted and wanted to know if staff could also negotiate with Paradies Lagardere for Food & Beverage Package 1. City Manager Walsh clarified that Paradies Lagardere did not bid on the Food & Beverage Package so staff would not recommend negotiating with them.

Councilmember Viagran requested to see the scoring and noted that Host True Flavors scored 40 points higher than the other Food & Beverage bidder and felt that allowing staff to negotiate both packages would save time and money.

Councilmember Courage noted that in B Session, City staff recommended competitive bids and a new RFP for Package 1. He mentioned that the RFP stated that the City would not award both contracts to the same vendor. Councilmember Courage asked when these new restaurants would open for business. Coyle indicated that there was a construction phase before the restaurants would open.

Mayor Nirenberg noted that Paradies Lagardere submitted an incredibly exciting retail package. Mayor Nirenberg recognized that there would not be another airport terminal in the world that included the best culinary talent in Texas, with a few missing pieces. However, according to the Mayor, bringing the authentic San Antonio experience to the airport would give visitors a taste of San Antonio and he recommended that Visit San Antonio market these restaurants.

City Manager Walsh reminded the City Council that this was an overall excellent package for Retail, Food & Beverage at the airport.

**PUBLIC COMMENT:**

Patrick Von Dolen and Mike Knuffle urged the funding not to be used for abortion or travel to other states for women to seek an abortion. Both provided oral and written testimony.

Jack Finger spoke in opposition to the Item.

**DISCUSSION:**

Councilmember Cabello Havrda stated that this was an important vote to ensure that women had access to important healthcare services and access to make informed choices about their future and she fully supported the work of the agencies receiving funding.

Councilmember Whyte clarified that none of the funds would be used to support out of state travel for abortions and he was pleased it was not going to fund the travel, however, he still did not support the Reproductive Justice Fund because it was set up from the beginning to fund abortion access and thought residents were confused about the Fund.

Councilmember Courage stated that his office sent an email to 10,000 Council District 9 residents and 68% stated that they did not want the City to fund travel for out of state abortions, while 25% indicated that they supported funding for travel. Councilmember Courage supported a woman's right to choose an abortion and access to healthcare but did not think taxpayer money should be used for travel out of state. He clarified that even though the Fund originally anticipated funding travel for abortions, today's contracts did not include it.

Councilmember McKee-Rodriguez stated that the Fund was set up to provide Reproductive Justice and give women the right to bodily autonomy and making their own healthcare decisions. He suggested that it was now dangerous to be pregnant in Texas due to an abortion ban. Even though the agencies that responded to the RFP did not propose travel,

the work they proposed was very important and he supported their work, however, he still supported funding for travel. Councilmember McKee-Rodriguez noted that this was not only a women's health issue but also an equity issue.

Councilmember Castillo noted that one in five residents lacked health insurance and these funds were needed to help provide healthcare and support reproductive rights. She supported a continued effort to fund more healthcare and reproductive support services.

Councilmember Kaur supported comprehensive women's health and that included whatever it meant to help a woman be healthy including an abortion.

Councilmember Pelaez commented that women died when they did not have access to the full spectrum of health care. He was happy that the contracts provided education and other services, but he agreed that women should be able to access all levels of healthcare, however, he did not think it was the municipality's role to pay for travel.

Councilmember Viagran thanked all the agencies that applied for contracts and supported the recommendation. She also thanked Councilmember Castillo for bringing the issue forward. Councilmember Viagran noted that there was a high need for women's health in Council District 3. She commented that women did not have the right over their own bodies and the Fund should help anywhere services were lacking.

Mayor Nirenberg stated that he appreciated the comments and supported the contracts. He clarified that out of state travel services were not being funded with the action today and he would support a conversation about the issue outside of these contracts. Mayor Nirenberg was pleased that the women on the City Council were leading the conversation.
