ORDINANCE

**AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH THE
UNIVERSITY OF TEXAS HEALTH SCIENCE CENTER AT SAN
ANTONIO TO PROVIDE DENTAL TREATMENT FOR CHILDREN
REFERRED BY THE CITY OF SAN ANTONIO METROPOLITAN
HEALTH DISTRICT'S ORAL HEALTH PROGRAM IN AN AMOUNT UP
TO \$225,580.00 FOR THE TERM SEPTEMBER 1, 2024 THROUGH
AUGUST 31, 2025, WITH OPTIONS TO RENEW FOR THREE, ONE-
YEAR TERMS FOR A TOTAL AMOUNT UP TO \$705,580.00, INCLUSIVE
OF RENEWALS.**

WHEREAS, the Title V Maternal and Child Health Block Grant is one of the largest grant programs aimed at improving the health and wellbeing of mothers and children; and

WHEREAS, the dental services portion of the grant serves eligible children that do not qualify for Medicaid or CHIP; and

WHEREAS, through this Program, children six months to 17 years of age are connected to comprehensive dental treatment; and

WHEREAS, children identified as having extensive dental needs beyond the scope of preventive services offered by Metro Health will be referred to the University of Texas Health Science Center at San Antonio (UT Health); and

WHEREAS, during FY 2023 the Oral Health Program provided access to care to 642 children who otherwise would have gone without receiving restorative treatment; and

WHEREAS, the City issued a Request for Qualifications for "Title V Maternal and Child Block Grant Dental Services" (RFQ 24-085, 6100017854) on April 11, 2024, with a submission deadline of May 28, 2024; and

WHEREAS, after committee review and evaluation, UT Health was recommended for award by the evaluation committee based on consensus scoring; and

WHEREAS, the initial term of the contract will begin September 1, 2024 through August 31, 2025, with three, one-year renewal options as authorized by this ordinance; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, or the Director of the San Antonio Metropolitan Health District or designee, is authorized to accept an agreement with the University of Texas Health Science Center at San Antonio to provide dental treatment for children referred by the San Antonio Metropolitan Health District’s Oral Health program in an amount up to \$225,580.00 for the term September 1, 2024 through August 31, 2025, with options to renew for three, one-year terms for a total amount up to \$705,580.00, inclusive of renewals. A copy of the agreement in substantially final form is attached hereto and incorporated herein for all purposes as **Attachment I**.

SECTION 2. Current funding is available from General Ledger 5201040, Cost Center Number 3618010004 and Fund 11001000 entitled “General Fund”, for a total amount up to \$71,500.00. Payment not to exceed the budgeted amount is authorized to UT Health upon issuance of a purchase order.

SECTION 3. Current funding is available from General Ledger 5201040, Internal Order Number 836000000xxx and Fund 29658000 entitled “Medicaid Waiver Fund”, for a total amount up to \$92,500.00. Payment not to exceed the budgeted amount is authorized to UT Health upon issuance of a purchase order.

SECTION 4. Current funding is available from General Ledger 5201040, Internal Order Number 136000001015 and Fund 2201636192 entitled “Title V Dental 25”, for a total amount up to \$61,580.00. Payment not to exceed the budgeted amount is authorized to UT Health upon issuance of a purchase order.

SECTION 5. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 6. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
