#### **PUBLIC COMMENT:**

Jack Finger questioned the terms of appointment and whether the Mayor would step down after his term expired.

#### **DISCUSSION:**

Councilmember Courage requested clarification on the term of the appointments noting that two members would be term-limited out before the end of their appointment and asked if they would continue to serve beyond their terms on the CPS Energy Board. City Attorney Andy Segovia explained that once the new Mayor was seated, there would be a new resolution to appoint the new Mayor to the seat and if a CPS Board member left, there would be a new appointment.

Councilmember Viagran asked whether the Public Facility Corporation (PFC) required the Mayor to hold the seat. Segovia stated that the PFC was comprised of the CPS Energy Board and the current bylaws of the CPS Energy Board required the Mayor to hold the seat representing the City of San Antonio. She clarified that the City Council had approval authority for all CPS Energy Board members.

Mayor Nirenberg pledged a peaceful transfer of power.

Councilmember Castillo noted that at the Municipal Utilities Committee, the public had expressed

concern with transparency and the need for public discussions with the CPS Energy Board, the PFC, and subcommittees. She confirmed that her expectation was that the PFC had public discussions during open meetings and would not extensively utilize Executive Sessions.

Councilmember Whyte agreed that transparency was important at CPS Energy noting that rates had been raised.

Mayor Nirenberg noted that all meetings of the PFC were open to the public and the Committee did not have any subcommittees.
