ORDINANCE

APPROVING A CONTRACT WITH FARRWEST ENVIRONMENTAL SUPPLY, INC., FOR CHEMICAL SAMPLING EQUIPMENT FOR THE SAN ANTONIO FIRE DEPARTMENT, OFFICE OF EMERGENCY MANAGEMENT, FOR A TOTAL COST OF \$81,702.70. FUNDING IS FROM THE HOMELAND SECURITY GRANT PROGRAM, FY 2022 URBAN AREA SECURITY INITIATIVE (UASI) GRANT.

WHEREAS, an offer was submitted by FarrWest Environmental Supply, Inc., to provide the San Antonio Fire Department, Office of Emergency Management, with chemical sampling equipment for a total cost of \$81,702.70; and

WHEREAS, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(2), which provides for a procurement necessary to protect the public health or safety; and

WHEREAS, funding for this contract is available from the Department of Homeland Security Grant Program, FY 2022 Urban Area Security Initiative (UASI) grant; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The offer submitted by FarrWest Environmental Supply, Inc., to provide the San Antonio Fire Department, Office of Emergency Management, with chemical sampling equipment for a total cost of \$81,702.70 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. A copy of the bid tabulation sheet and contract are attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. Funding is available in Internal Order 120000000232, GLs 5304050 and 5709060 for a total amount of \$82,000.00.

SECTION 3. Payment not to exceed the budgeted amount is authorized to be encumbered with a purchase order and made payable to FarrWest Environmental Supply, Inc.

SECTION 4. The financial allocations in this ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager, or the City Manager's designee, correct allocation to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.
