

**FIRST AMENDMENT
TO
AGREEMENT FOR
CONCEALABLE BODY ARMOR FOR
SAPD AND OTHER LAW ENFORCEMENT OFFICERS**

This Amendment is entered into by and between the **City of San Antonio**, a Texas Municipal Corporation, (hereinafter referred to as "City"), acting by and through its City Manager or designee, pursuant to Ordinance No. _____ passed and approved on the _____ day of _____, 20____ and **Nardis, Inc.**, (hereinafter referred to as "Nardis" or "Contractor"). City and Nardis may be referred to herein collectively as the "Parties".

WHEREAS, pursuant to Ordinance No. 2019-12-05-0977, the City entered into an Agreement for Concealable Body Armor for the San Antonio Police Department (SAPD) and Other Law Enforcement Officers with Nardis, Inc., that commenced on December 5, 2019, and as renewed, expires on December 4, 2024 (hereinafter referred to as "the Agreement"); and

WHEREAS, the Parties agree that the Agreement should be revised to extend the term for an additional two-year period so that SAPD can continue to purchase concealable body armor under this Agreement until the certification process for the new National Institute of Justice (NIJ) Standard is complete; and

WHEREAS, it is in the best interest of the City that an amendment of the Agreement now be executed; **NOW THEREFORE:**

The Parties hereto severally and collectively agree, and by the execution hereof are bound, to the mutual obligations herein contained and to the performance and accomplishment of the tasks hereinafter described. City and Nardis agree to amend the Agreement to add the following:

**ARTICLE 1
AMENDMENTS**

1.1 Article II, Term, Sections 2.1 and 2.2 are hereby deleted and replaced with:

Contract Term. Unless sooner terminated in accordance with the provisions of this Agreement, the term of this Agreement began on December 5, 2019, and shall terminate on December 4, 2026.

ARTICLE 2
PROVISIONS REMAIN IN EFFECT

All other terms, conditions, covenants and provisions of the above referenced contract, as previously amended, not specifically mentioned herein and revised by this document, are retained in their entirety, unchanged, and remain in full force in effect for the duration of said contract, and any renewals thereof.

EXECUTED and AGREED to as of the dates indicated below. This Amendment may be executed in any number of counterparts, each of which shall be deemed an original and constitute one and the same instrument.
