FIELD NOTES DESCRIPTION

Being a 0.161-acre, (7,019 Square Feet) tract of land out of a called 5.740-acre tract of land described by deed recorded in Volume 10268, Page 1506, Official Public Records of Bexar County, Texas, being Lot P-4, N.C.B. 17194, Green Spring Valley Annexation, City of San Antonio, Bexar County, Texas. Said 0.161-acre tract being more particularly described as follows, with bearings based on the North American Datum of 1983 (CORS 1996) from the Texas State Plane Coordinate System, Texas South Central Zone (4204):


BEGINNING at a 1/2-inch iron rod with cap marked "M&J 3576" found on the north line of called 5.00-acre tract of land described in a deed of trust recorded in Volume 15834, Page 369, Official Public Records of Bexar County, Texas, said 5.00-acre tract part of a called 10.0-acre tract of land, conveyed to Milton Eisenhower, Jr. by deed recorded in Volume 11868, Page 1905, Official Public Records of Bexar County, Texas, and being the southeast corner of said 5.740-acre, for the southeast corner of this herein described tract. Said 1/2-inch iron rod having state plane coordinate values of, X=2,151,509.25, Y=13,762,860.75.

Thence N 81°38'31" W, along the common line of said 5.00-acre tract and said 5.740-acre tract, a distance of 10.00 feet to a point, for the southwest corner of this herein described tract;

Thence N 07°35'35" W, a distance of 705.83 feet to a point of curvature on the north line of said 5.740-acre tract and the south Right-of-Way line curve return of Redland Road, for the northwest corner of this herein described tract;

Thence along a curve to the right with radius of 15.00 feet, an arc length of 18.46 feet, delta angle of 70°31'17", a chord bearing of S 42°51'40" E and chord length of 17.32 feet, to a point of curvature of a tangent curve to the left on the west Right-of-Way line of Bulverde Road;

Thence S 07°35'35" E, along the east line of said 5.740-acre tract and the west Right-of-Way line of Bulverde Road, a distance of 691.56 feet to the **POINT OF BEGINNING**, and containing 0.161 acres, (7,019 Square Feet) of land, more or less.

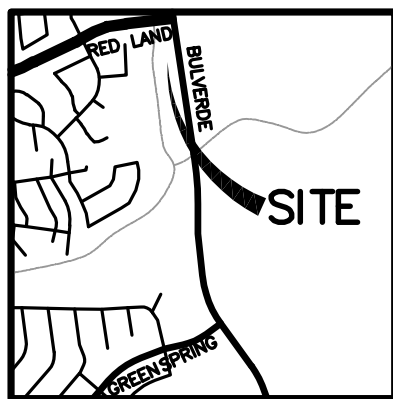

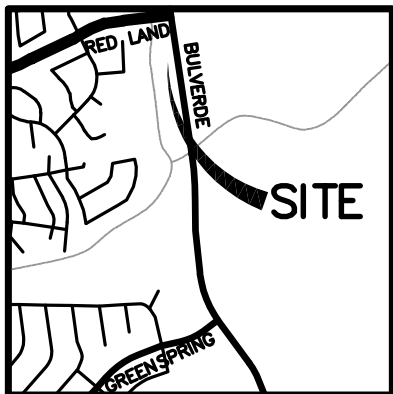

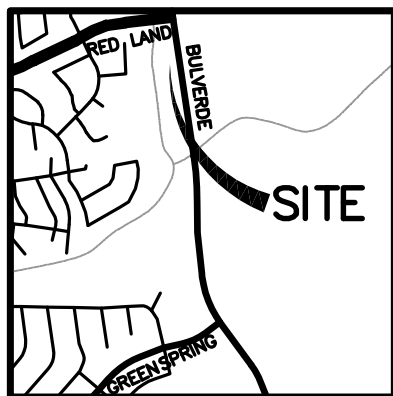

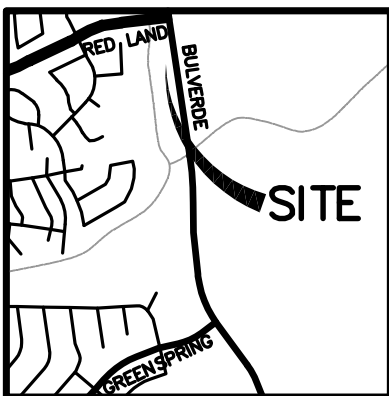
