Dalia Flores Contreras provided a report on the State of Education in San Antonio prepared by her agency, City Education Partners, and spoke in support of high-quality primary education. Jillian Duran and Gladys Hernandez suggested ways the City Council could help improve student education. Daiana Lambrecht, Sandra Valdez, and Michael Ratliffe with Futuro San Antonio spoke in support of improved education.

Eric Dover demanded that San Antonio discontinue adding fluoride to San Antonio's drinking water and maintained that this caused brain damage in children.

Mike Knuffke with the San Antonio Family Association spoke against the Reproductive Justice Fund being used for transportation for women to seek an out-of-state abortion. Knuffke opposed using taxes to pay for VIA Metropolitan Transit and stated that bus fares only cover \$0.8 per dollar. He suggested that the City was using housing funding to support transit.

Deborah Castoreno requested support for Israel and complained about air pollution from CPS Energy nuclear power plants.

Richard Garcia requested a call back from 3-1-1 and spoke regarding the Memorial Branch Library.

John Bachman spoke in support of moving Animal Care Services to the no-kill status including more spay/neuter surgeries.
