

## **FIRST AMENDMENT OF PROFESSIONAL SERVICES AGREEMENT**

This Amendment of the Professional Services Agreement for vaccination clinics is entered into by and between the City of San Antonio, a Texas Municipal Corporation (“City”) acting by and through the Interim Director of the Animal Care Services Department, (“ACS”) and Animal Defense League of Texas (“ADL”), a non-profit organization, by and through Kenny Hill, Chief Executive Director (“Contractor”) and is as follows:

**WHEREAS**, the Agreement, provided for an initial term of October 1, 2023, through September 30, 2024, and a total compensation amount of \$48,000; and

**WHEREAS**, the City wishes to amend the Agreement to increase the compensation to allow for ADL to continue to perform no cost animal vaccination services and microchipping for the remainder of the term of the Agreement; and

**WHEREAS**, the parties wish to amend this Agreement to amend the compensation for this Agreement;  
**NOW THEREFORE:**

### **I. Amendment**

Section 3.3 of the Agreement is hereby amended to read as follows:

3.3 Contractor shall be responsible for serving 2,650 dogs and cats annually at each no-cost clinics, to include: Rabies, Distemper/Hepatitis/Parvovirus/Parainfluenza (DHPP), and Feline Viral Rhinotracheitis/Calicivirus/Panleukopenia (FVRCP). Contractor shall not charge pet owners for the vaccinations provided at the clinics.

Section 4.1 of the Agreement is hereby amended to read as follows:

4.1 In consideration of Contractor’s performance in a satisfactory and efficient manner, as determined solely by Director, of all services and activities set forth in this Agreement, City agrees to pay Contractor an amount not to exceed \$53,000.00, as total compensation, to be paid to Contractor as follows:

4.1.1 Contractor shall be paid at the rate of \$20.00 per animal that receives vaccinations and microchip at a no-cost clinic. This shall represent the total amount received from all sources, the pet owner or otherwise, for each pet receiving services.

### **II.**

All other terms, conditions, covenants and provisions of the are hereby in effect, renewed and extended, save and except those terms which the Parties have amended.
