

**ZONING DESCRIPTION**

**BEING** A 77.14 ACRE (3,360,098 SQUARE FEET) TRACT OF LAND SITUATED IN THE JOSE ANTONIO DE LA GARZA SURVEY, ABSTRACT NO.3, BEXAR COUNTY, TEXAS, BEING A PORTION OF NEW CITY BLOCK 15667 AND BEING A PORTION OF A CALLED 80.420 ACRE TRACT DESCRIBED IN DEED WITHOUT WARRANTY TO JEN TEXAS 29 LLC RECORDED IN DOCUMENT NO. 20210279111, OFFICIAL PUBLIC RECORDS, BEXAR COUNTY, TEXAS, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

**BEGINNING** AT A 1/2" IRON ROD WITH YELLOW PLASTIC CAP STAMPED "PAPE DAWSON" FOUND IN THE WEST RIGHT-OF-WAY LINE OF FLORES ROAD, THE NORTHEAST CORNER OF A TRACT OF LAND DESCRIBED IN QUITCLAIM DEED TO KATHLEEN P. NICHOLAS IN VOLUME 10385, PAGE 33, DEED RECORDS, BEXAR COUNTY, TEXAS, A SOUTHEAST CORNER OF SAID 80.420 ACRE TRACT AND THE HEREIN DESCRIBED TRACT;

**THENCE** DEPARTING SAID WEST RIGHT-OF-WAY LINE OF FLORES ROAD AND ALONG THE NORTH LINE OF SAID KATHLEEN P. NICHOLAS TRACT, THE SOUTH LINE OF SAID 80.420 ACRE TRACT AND THE HEREIN DESCRIBED TRACT THE FOLLOWING FIVE (5) CALLS;

1. SOUTH 80°09'54" WEST, 175.77 FEET TO A 1/2" IRON ROD WITH YELLOW PLASTIC CAP STAMPED "PAPE DAWSON" FOUND FOR CORNER;
2. SOUTH 00°22'07" EAST, 177.93 FEET TO A 1/2" IRON ROD WITH YELLOW PLASTIC CAP STAMPED "PAPE DAWSON" FOUND FOR CORNER;
3. SOUTH 89°16'49" WEST, 840.60 FEET TO A 1/2" IRON ROD WITH YELLOW PLASTIC CAP STAMPED "PAPE DAWSON" FOUND FOR CORNER;
4. NORTH 00°44'01" WEST, 632.14 FEET TO A 1/2" IRON ROD WITH YELLOW PLASTIC CAP STAMPED "PAPE DAWSON" FOUND FOR CORNER;
5. SOUTH 89°32'56" WEST, 353.64 FEET TO A POINT IN THE EAST RIGHT-OF-WAY LINE OF HIGHWAY 281, THE NORTHWEST CORNER OF SAID KATHLEEN P. NICHOLAS TRACT, THE SOUTHWEST CORNER OF SAID 80.420 ACRE TRACT AND THE HEREIN DESCRIBED TRACT, FROM WHICH A 1/2" IRON ROD FOUND BEARS NORTH 89°32'56" EAST, 1.58 FEET;

**THENCE** NORTH 00°38'17" WEST, 1830.80 FEET ALONG SAID EAST RIGHT-OF-WAY LINE OF HIGHWAY 281, THE WEST LINE OF SAID 80.420 ACRE TRACT AND THE HEREIN DESCRIBED TRACT TO A POINT FOR CORNER;

**THENCE** DEPARTING SAID EAST RIGHT-OF-WAY LINE OF HIGHWAY 281, THE WEST LINE OF SAID 80.420 ACRE TRACT AND OVER AND ACROSS SAID 80.420 ACRE TRACT THE FOLLOWING THREE (3) CALLS:

1. NORTH 89°18'44" EAST, 337.06 FEET TO A POINT FOR CORNER;
2. NORTH 00°38'17" WEST, 420.03 FEET TO A POINT FOR CORNER;
3. SOUTH 89°18'44" WEST, 337.06 FEET TO A POINT FOR CORNER IN SAID EAST RIGHT-OF-WAY LINE OF HIGHWAY 281, THE WEST LINE OF SAID 80.420 ACRE TRACT;

**THENCE** NORTH 00°38'17" WEST, 775.27 FEET ALONG SAID EAST RIGHT-OF-WAY LINE OF HIGHWAY 281, THE WEST LINE OF SAID 80.420 ACRE TRACT AND THE HEREIN DESCRIBED TRACT TO A POINT FOR THE NORTHWEST CORNER OF SAID 80.420 ACRE TRACT AND HEREIN DESCRIBED TRACT, FROM WHICH A 1/2" IRON ROD BEARS SOUTH 73°53'45" EAST, 0.25 FEET;

**THENCE** SOUTH 73°53'45" EAST, 780.92 FEET DEPARTING SAID EAST RIGHT-OF-WAY LINE OF HIGHWAY 281 AND ALONG THE NORTH LINE OF SAID 80.420 ACRE TRACT AND THE HEREIN DESCRIBED TRACT TO A POINT IN SAID WEST RIGHT-OF-WAY LINE OF FLORES ROAD, FOR THE NORTHEAST CORNER OF SAID 80.420 ACRE TRACT AND THE HEREIN DESCRIBED TRACT, FROM WHICH A 5/8" IRON ROD FOUND BEARS SOUTH 73°53'45" EAST, 0.34 FEET;

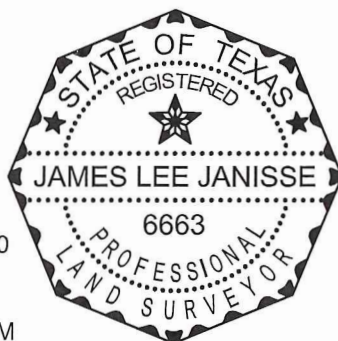

1. SOUTH 13°47'53" EAST, 1,008.52 FEET TO A TXDOT TYPE I CONCRETE MONUMENT AT THE BEGINNING OF A NON-TANGENT CURVE TO THE RIGHT WITH A RADIUS OF 1,392.69 FEET, A CENTRAL ANGLE OF 06°41'06", AND A CHORD BEARING AND DISTANCE OF SOUTH 10°18'52" EAST, 162.40 FEET;
2. IN A SOUTHERLY DIRECTION, WITH SAID NON-TANGENT CURVE TO THE RIGHT, AN ARC DISTANCE OF 162.49 FEET TO A TXDOT TYPE I CONCRETE MONUMENT (DAMAGED) FOR CORNER;
3. SOUTH 07°03'57" EAST, A DISTANCE OF 1,224.03 FEET TO A TXDOT TYPE I CONCRETE MONUMENT AT THE BEGINNING OF A NON-TANGENT CURVE TO THE LEFT WITH A RADIUS OF 1,950.08 FEET, A CENTRAL ANGLE OF 10°13'51", AND A CHORD BEARING AND DISTANCE OF SOUTH 12°09'22" EAST, 347.75 FEET;
4. IN A SOUTHERLY DIRECTION, WITH SAID NON-TANGENT CURVE TO THE LEFT, AN ARC DISTANCE OF 348.21 FEET TO A TXDOT TYPE I CONCRETE MONUMENT FOR CORNER;
5. SOUTH 17°20'23" EAST, A DISTANCE OF 551.27 FEET TO THE **POINT OF BEGINNING** AND CONTAINING 3,360,098 SQUARE FEET OR 77.14 ACRES OF LAND.

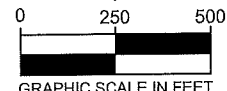
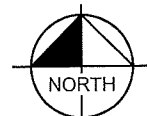
