ORDINANCE

APPROVING THE ACCEPTANCE OF GRANT FUNDS IN THE AMOUNT OF \$180,000.00 FROM OFFICE OF THE GOVERNOR, PUBLIC SAFETY OFFICE, FOR THE STATE AND LOCAL CYBERSECURITY GRANT PROGRAM FOR NOVEMBER 1, 2024, TO OCTOBER 31, 2025. THE GRANT AMOUNT IS FOR \$180,000.00 WITH A \$50,000.00 CASH MATCH FOR A TOTAL GRANT BUDGET OF \$230,000.00

WHEREAS, the federal Infrastructure Investment and Jobs Act (IIJA), also known as the Bipartisan Infrastructure Law (BIL), signed into law on November 15, 2021, included in BIL is the State and Local Cybersecurity Grant Program (SLCGP), and

WHEREAS, the SLCGP appropriated \$1 billion over four years (2022-2025) to address cybersecurity risks and cybersecurity threats to information systems owned or operated by, or on behalf of, state, local, or tribal governments; and

WHEREAS, in FY 2022, the SLCGP allocated \$8,469,945.00 to Texas to be spent on cybersecurity projects for FY 2022; and

WHEREAS, the City submitted a grant application in March 2024 for the FY 2022 award year under the Assessment and Evaluation focus area and received award notice in December 2024; and

WHEREAS, the grant amount is for \$180,000.00 with a \$50,000.00 cash match by the City for a total grant budget of \$230,000.00; and

WHEREAS, the total grant budget will be used to purchase the first year of the Threat Intelligence Platform product for use by the City and the Alamo Regional Security Operations Center (ARSOC) partners; and

WHEREAS, the threat intelligence information obtained from the tool will be curated, processed and shared with the partners as the means to strengthen the cooperation and cybersecurity for the area community which ultimately benefits the cybersecurity posture of the City of San Antonio.

NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The acceptance of grant funds in the amount of \$180,000.00 from the Office of the Governor, Public Safety Office, for the State and Local Cybersecurity Grant Program with a

\$50,000.00 cash match is hereby approved. The City Manager or designee, or the Chief Information Officer or designee, is hereby authorized to enter and execute any documents necessary to carry out the purposes of this Ordinance.

SECTION 2. Funds in the amount of \$180,000.00 are authorized to be received and appropriated in Fund xxxxxxx, Internal Order 10900000xxxx and GL Account 6102100.

SECTION 3. Funds in the amount of \$180,000.00 are authorized to be appropriated in Fund 40099000, Project 09-00176, WBS Element 09-0017690-07-01 and GL Account 6101100.

SECTION 4. Funds in the amount of \$180,000.00 are authorized to be appropriated in Fund 40099000, Project 09-00176, WBS Element 09-0017690-01 and GL Account 5203080.

SECTION 5. Funds in the amount of \$50,000.00 for the required cash match are available in Fund 40099000, Project 09-00176, WBS Element 09-00176-01 and GL Account 5203080.

SECTION 6. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance

SECTION 7. This Ordinance shall be effective immediately upon passage by at least eight (8) votes and the 10th day after passage if by fewer than eight (8) votes.
