2. **Briefing and possible action related to support of the crisis nursery initiative to be considered by City Council**

A COSA RFP will be released in March regarding the Crisis Nursery Initiative.

Helterbrand requested that the Commission members promote and send a letter to their councilmember advocating funding for the Crisis Nursery Initiative.

Letter will be worded for Commission members to individually submit and not submitted as a body.

3. Briefing by the Scholarship Subcommittee and possible action related to recommendations for the scholarship funds

Amy Carcanagues, Director of Scholarship Program, and Jan Mundine, Donor Engagement and Stewardship Manager, from the Alamo Colleges Foundation spoke on behalf of their program and the applicant pool that is available for scholarships at the Alamo Colleges District.

\$80,000 is available from the Scholarship fund for the Mayor's Commission on the Status of Women to provide scholarships.

Criteria for scholarship selection will be tabled for next meeting.

Anamaria Suescun-Fast made a motion for \$40,000 from the Scholarship fund to be allocated to the Alamo Colleges District for up to \$1,000 for up to 4 semesters per student.
