

**AMENDMENT III TO AGREEMENT  
WITH FASTER ASSET SOLUTIONS**

This Amendment III is entered into by and between the **City of San Antonio**, a Texas Municipal Corporation, (hereinafter referred to as “City”), acting by and through its Director of Finance or said Director’s designee (“Director”), pursuant to Ordinance No. \_\_\_\_\_ passed and approved on the \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, and **TT Faster LLC, dba FASTER Asset Solutions**, (hereinafter referred to as “Vendor”). City and Vendor may be referred to herein collectively as the “Parties”.

**WHEREAS**, pursuant to Ordinance No. 2019-04-11-0298, passed and approved on April 11, 2019, the City entered into an agreement with CCG Systems, Inc., dba FASTER Asset Solutions (“CCG”) to upgrade the City’s Fleet Management System and for continued maintenance and support, which as amended and renewed, ends on April 11, 2024 (hereinafter referred to as “the Agreement”); and

**WHEREAS**, CCG was sold via an asset sale to TT Faster LLC, dba FASTER Asset Solutions, on December 23, 2019, and the Agreement was assigned to TT Faster LLC, dba FASTER Asset Solutions in Amendment I; and

**WHEREAS**, it is in the City’s best interest and Parties agree to amend the Agreement to extend the term through August 31, 2024, and add five additional, one-year periods for continued annual support and maintenance for the FASTER Fleet Maintenance Software Site License; and

**WHEREAS**, the Texas Local Government Code indicates that competitive bidding is not required under section 252.022(a)(7)(A), which provides for any items that are available only from a sole source of supply, and

**NOW THEREFORE**, the Parties hereto severally and collectively agree, and by the execution hereof are bound, to the mutual obligations herein contained and to the performance and accomplishment of the tasks hereinafter described. City and Vendor agree to amend the Agreement as follows:

**ARTICLE I  
AMENDMENTS**

- 1.1 The Agreement is revised (a) to extend the contract term from April 11, 2024 – August 31, 2024, for a total cost of \$52,066.90 which has been paid by City, (b) to extend the term through August 31, 2025, for an annual fee of **\$128,709.36** and (c) to add four additional, one-year renewal periods for continued annual support and maintenance for the FASTER Fleet Maintenance Software Site License, as follows:

Renewals. At City’s option, this contract may be renewed under the same terms and conditions for four (4) additional, one (1) year periods for the annual fees listed below:

- a) September 1, 2025, through August 31, 2026, for an annual fee of **\$132,570.64**
- b) September 1, 2026, through August 31, 2027, for an annual fee of **\$136,547.75**
- c) September 1, 2027, through August 31, 2028, for an annual fee of **\$140,644.19**
- d) September 1, 2028, through August 31, 2029, for an annual fee of **\$144,863.51**

Renewals shall be in writing and signed by the Director, without additional City Council approval, subject to and contingent upon appropriation of funding therefor.

**ARTICLE II**  
**PROVISIONS REMAIN IN EFFECT**

All other terms, conditions, covenants and provisions of the Agreement not specifically mentioned herein and revised by this Amendment, are retained in their entirety, unchanged, and remain in full force in effect for the duration of said Agreement, and any renewals thereof.

**ARTICLE III**  
**ENTIRE AGREEMENT**

This agreement, as amended, embodies the complete agreement of the parties hereto with regard to the subject matter contained herein, superseding all oral or written previous and contemporary agreements between the parties relating to matters herein.

**EXECUTED** and **AGREED** to as of the dates indicated below. This Amendment may be executed in any number of counterparts, each of which shall be deemed an original and constitute one and the same instrument.
