

## ORDINANCE

**ACCEPTING A GRANT IN AN AMOUNT UP TO \$90,000 FROM THE TEXAS DEPARTMENT OF TRANSPORTATION AS PART OF THE ROUTINE AIRPORT MAINTENANCE PROGRAM, WITH A CITY MATCH OF \$10,000 FOR IMPROVEMENTS TOTALING \$100,000 AT THE STINSON MUNICIPAL AIRPORT WITH FUNDING FOR THE CITY MATCH FROM STINSON REVOLVING FUNDS AND INCLUDED IN THE FY 2025 – FY 2030 CAPITAL IMPROVEMENT PROGRAM.**

**WHEREAS**, the Aviation Division for TXDOT helps cities and counties obtain and disburse federal and state funds for general aviation airports in the Texas Airport System Plan, which includes Stinson Municipal Airport; and

**WHEREAS**, TXDOT administers the Routine Airport Maintenance Program (RAMP) which matches local government grants for basic airport improvements; and

**WHEREAS**, RAMP grants have assisted in addressing several smaller-scale projects at Stinson Municipal Airport such as the build-out of office space within the terminal building, storm water outfall repairs, roof repairs to city-owned hangars and buildings and upgrades to airfield lighting and signage; and

**WHEREAS**, this year's grant funds are planned to replace the Precision Approach Path Indicators (PAPI) with a new LED system; and

**WHEREAS**, this ordinance accepts a grant in an amount up to \$90,000 from the Texas Department of Transportation (TXDOT) as part of the Routine Airport Maintenance Program (RAMP), with a City match of \$10,000 for improvements totaling \$100,000 at the Stinson Municipal Airport; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or designee, or the Director of the Aviation Department or designee, is authorized to execute a grant acceptance agreement between the City of San Antonio and Texas Department of Transportation (TxDOT) accepting total funding of \$90,000.00 as part of the Routine Airport Maintenance Program. This ordinance authorizes a cash match in the amount up to \$10,000.00. A copy of the agreement in substantially final form is attached hereto and incorporated herein for all purposes as **Attachment 1**.

**SECTION 2.** The City Manager or designee, or the Director of the Aviation Department or designee, is further authorized to execute any and all necessary documents to effectuate said agreement and acceptance.

**SECTION 3.** The budget in Fund 51099000, Project 33-03329, STINSON BUILDING MODIFICATIONS - FY25, shall be revised by appropriating \$90,000.00 in WBS 33-03329-90-06-01 with GL Account 6101100 and \$90,000.00 in WBS 33-03329-05-02 with GL Account 5201140.

**SECTION 4.** The City Match requirement of \$10,000.00 is available in Fund 51099000, WBS 33-03329-05-02 and GL Account 5201140 from previously approved appropriations and included in the FY 2025 – FY 2030 Capital Improvement Program.

**SECTION 5.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 6.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
