ORDINANCE

**ACCEPTING THE LOWEST RESPONSIVE BID AND AWARDING
THE 2025 PAVEMENT PRESERVATION PACKAGE 16 -
REFLECTIVE PAVEMENT TASK ORDER CONTRACT TO STRIPE
IT UP, LLC IN AN AMOUNT NOT TO EXCEED \$2,470,426.48.
FUNDS ARE AVAILABLE FROM THE RESILIENCY, ENERGY
EFFICIENCY, AND SUSTAINABILITY FUND FY 2025 BUDGET**

WHEREAS, as part of the FY 2023 Adopted Budget, the Resiliency, Energy Efficiency and Sustainability Program Fund was established, and one of the program's objectives includes Urban Heat Island Mitigation to reduce temperatures in the hottest part of the City's urban core; and

WHEREAS, and in alignment with the heat mitigation strategies in the City's Climate Action and Adaptation Plan (CAAP), Public Works and the Office of Sustainability are utilizing cool pavement as a mechanism to not only preserve the life of our pavements but to also make the streets cooler, healthier, and more sustainable; and

WHEREAS, the FY 2025 adopted budget includes funding in the amount of \$5.8 million to apply cool pavement applications to 22.35 miles of pavement identified in Urban Heat Island areas; and

WHEREAS, this ordinance authorizes one contract for FY 2025 totaling \$2,470,426.48 to provide complete cool pavement preservation projects as part of the FY 2025 Cool Pavement Program; and

WHEREAS, this project was advertised for construction bids on March 19, 2025, and six (6) bids were received and opened on April 18, 2025, of which Stripe It Up, LLC, submitted the lowest responsive bid after the lowest bidder withdrew their bid; and

WHEREAS, this contract will be awarded in compliance with the Small Business Economic Development Advocacy (SBEDA) Program, which requires contracts be reviewed by a Goal Setting Committee to establish a requirement and/or incentive unique to the particular contract to maximize the amount of small, minority and women-owned business participation on the contract. This contractor has committed to meeting the subcontractor participation goals; and

WHEREAS, this vendor has acknowledged and will comply with the Heat Illness Prevention Ordinance, approved on August 31, 2023, through Ordinance #2023-08-31-0585; and

WHEREAS, as part of the department's continuing efforts to expedite project delivery and complete infrastructure projects, the task order contract will enable Public Works to execute multiple projects delivered through the Cool Pavement Program; and

WHEREAS, this ordinance accepts the lowest responsive bid and awards the 2025 Pavement Preservation Package 16 - Reflective Pavement Task Order Contract to Stripe It Up, LLC in an amount not to exceed \$2,470,426.48; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, or the Director of the Public Works Department or designee, is authorized to award the 2025 Pavement Preservation Package 16 - Reflective Pavement Task Order Contract to Stripe It Up, LLC in an amount not to exceed \$2,470,426.48.

SECTION 2. Funds for this ordinance in the amount of \$2,470,426.48 is available in Fund 11001009, Cost Center 2380010001 and GL Account 5201140.

SECTION 3. Payment not to exceed \$2,470,426.48 is authorized to be encumbered with a purchase order and made payable to Stripe It Up, LLC. Payment is in support of the street maintenance program. Funds are available from the Resiliency, Energy Efficiency, and Sustainability Fund.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
