**ORDINANCE**

**APPROVING A PROFESSIONAL SERVICES AGREEMENT WITH ARRIVE MOBILITY, INC., D/B/A FLASH PARKING, TO PROVIDE OFF-SITE EVENT PARKING BOOKING SERVICES TO THE ALAMODOME DURING EVENT DAYS, FOR A THREE-YEAR TERM WITH TWO ONE-YEAR RENEWAL OPTIONS, FOR AN ESTIMATED ANNUAL COMMISSION TO THE CITY OF \$10,000.00.**

**WHEREAS,** The Alamodome hosts a wide range of events, with over 120 event days per year, including concerts, boxing, cheer competitions, motor sports, ice shows, conventions, community events, civic events, soccer, basketball and football games; and

**WHEREAS,** in an effort to elevate the patron experience and to position the Alamodome and the City of San Antonio as the preferred facility venue and destination the Convention & Sports Facilities Department is seeking to provide innovative technology that delivers reduced traffic congestion, convenience and increased parking revenue to the City of San Antonio; and

**WHEREAS,** the Convention & Sports Facilities Department solicited informal bids for “Event Parking Booking Services” during the month of June 2024 and two informal bids were received, and the Arrive Mobility d/b/a Flash Parking (“Flash Parking”) proposal is recommended for contract award based on their experience, background and qualifications, proposed plan and estimated revenue to the City; and

**WHEREAS,** under the proposed Professional Services Agreement (“Agreement”), Flash Parking will provide services that enable Alamodome patrons to find and book parking prior to arriving at their event via the Flash Parking websites ([www.parkwhiz.com](http://www.parkwhiz.com) and [www.bestparking.com](http://www.bestparking.com)), mobile applications and third party e-commerce platforms and Flash Parking will pay the City 20% of their net revenues on such qualifying transactions; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The terms and conditions of a Professional Services Agreement with Arrive Mobility, Inc., d/b/a Flash Parking, to provide off-site event parking booking services to the Alamodome during event days, for a three-year term with two one-year renewal options, for an estimated annual commission to the City of \$10,000.00, are authorized and approved. The City Manager, or his designee, is authorized to execute the Agreement, a copy of which, previously executed by Flash Parking, is attached to this Ordinance as **Exhibit I**.

**SECTION 2.** Funds received for this Ordinance for Event Parking Booking Services will be deposited in Fund 29016000, Internal Order 245000000030 and General Ledger 4403110.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance shall take effect immediately upon the receipt of eight affirmative votes; otherwise it shall be effective ten days after its passage.
