THENCE, S 65°38'57" E, a distance of 30.00', with the said south right of way line of Sweet Street, to a ½" iron rod set, the north corner of Tract 1, this day surveyed, the east corner of the herein described tract, from which a ½" iron rod found for the northeast corner of said tract 1, being at the intersection of the south line of said Sweet St. and the west right of way line of South Main Street (63' R.O.W.-per Pioneer Flour Mills Subdivision plat, Vol. 9538, Pg. 205, Plat Records Bexar County, Texas) bears, S 65°38'57" E, a distance of 74.96' (74.95'-per NCB map) for witness; ;
