City Council Project Funds Allocations

SUMMARY:

This Ordinance approves allocations through the City Council Project Fund (CCPF) for:

A) District 2 Back 2 School – PreK4SA
An event where the district provided school supplies to children within the district.

B) District 4 Back to School Project 2024
An event where the district provided school supplies to children within the district.

C) District 8 Superheroes and Villains 5k
A free health and fitness event hosted by the district and San Antonio Sports. First aid services, race management, venue rental, and event security were provided.

BACKGROUND INFORMATION:

CCPF was established in 2011 to provide financial support for events and programs that serve a municipal purpose and promote (1) the health, safety and welfare of the community; (2) family,

social and economic stability; (3) community fitness/recreation; and (4) community education and training. City Council approval is required for City Council Project Fund allocations exceeding \$10,000 to an applicant for the same program, activity, event, good, or service.

This ordinance awards:

A) \$11,696.46 in CCPF funding for the District 2 Back 2 School – PreK4SA event
An event where the district provided school supplies to children within the district.

A) \$15,343.58 in CCPF funding for the District 4 Back to School Project 2024
An event where the district provided school supplies to children within the district.

B) \$16,997.30 in CCPF funding for the District 8 Superheroes and Villains 5k
A free health and fitness event hosted by the district and San Antonio Sports. First aid services, race management, venue rental, and event security were provided.

ISSUE:

This ordinance seeks to approve several CCPF allocations, listed above, to support various District events and activities that meet the criteria for eligibility.

ALTERNATIVES:

City Council could choose not to approve these allocations.

FISCAL IMPACT:

These allocations were funded from the FY 2024 General Fund Budget for CCPF.
