## **POINT OF PERSONAL PRIVILEGE**

Mayor Nirenberg recognized the passing of Joyce Dorycott with a brief moment of silence.

Mayor Nirenberg recognized Alamo Colleges Board President Joe Alderete, Jr. and Chancellor Mike Flores for their work educating San Antonio and the Alamo Promise partnership that provided free college tuition to San Antonio high school graduates.
