The City Council convened the Public Comment Session in the Norma S. Rodriguez Council Chamber in the Municipal Plaza Building beginning at 5:04 PM. City Clerk Debbie Racca-Sittre took the Roll Call with the following Council Members present:

1. Councilmember Sukh Kaur will be sworn in as Mayor Pro Tem for the period of January 16, 2025 through April 2, 2025.

City Clerk Debbie Racca-Sittre swore-in Councilmember Kaur as Mayor Pro Tem before the meeting began.

Mayor Pro Tem Kaur called the meeting to order at 5:04 p.m.

Mayor Pro Tem Kaur read the Proclamation in honor of Dr. Martin Luther King (MLK), Jr. and proclaimed Monday, January 20, 2025 to be MLK March Day in San Antonio. Mayor Pro Tem Kaur recognized Councilmember McKee-Rodriguez who thanked the members of the MLK Commission for their work. Councilmembers McKee-Rodriguez, Viagran, Rocha Garcia, Castillo, Pelaez, and Courage spoke in support of the Proclamation.

Carl Merkle stated that he was a victim of kidnapping and requested that the City pay him.

Jason Paul stated that the City Council had received his email and they were a witness to a crime.

Martha Huerta stated that her son was in jail and asked for him to be released.

Nick Zbilowski stated that he was trying to overcome the injustice of being committed to a mental health facility and submitted a written statement.
