**ORDINANCE**

**AUTHORIZING THE SAN ANTONIO OFFICE OF  
EMERGENCY MANAGEMENT TO APPLY FOR, ACCEPT,  
AND APPROPRIATE UPON AWARD UP TO \$654,120.00  
FROM THE 2024/2025 STATE HOMELAND SECURITY  
PROGRAM GRANT.**

**WHEREAS**, there are grant funds of as much as \$545,100.00 available from the 2024/2025 state Homeland Security Program Grant (SHSP); and

**WHEREAS**, the purpose of the 2024/2025 SHSP is to enhance the ability of governments to prevent, respond to, and recover from acts of international terrorism and “all hazards” disasters impacting the Alamo Area Council of Government Region which encompasses the City, Bexar County and the surrounding 13 counties and suburban cities within these counties; and

**WHEREAS**, the total amount of money for the current applications is \$545,100, but this ordinance further provides the City may accept without further action by City Council additional funds up to 20% of this amount should it become available, for a total amount of \$654,120.00; and

**WHEREAS**, this grant does not require and accept a cash match or an in-kind contribution; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager and designee, and the Emergency Management Coordinator (EMC) and designee, are hereby authorized to submit a grant application and accept grant funds upon award in an amount up to \$654,120.00 for the 2024/2025 SHSP to assist the City in preventing, responding to, and recovering from acts of international terrorism and disasters, to fund implementation of the following projects:

- Grant ID 2963810 –Law Enforcement Regional Response Capabilities (\$151,000.00)
- Grant 4100805 - Southwest Texas Regional Fusion Center (\$224,100.00)
- Grant 5113801 - Web EOC Training and Administration (\$95,000.00)
- Grant 5116801 - RICC and WAVE Network Engineer (\$75,000.00)

**SECTION 2.** The City Manager and designee, and the EMC and designee, are hereby authorized to accept said grant, if awarded under substantially the same terms and conditions as applied for, and are further authorized to execute any and all documents necessary to effectuate said application and acceptance, and an additional \$109,020.00 awarded under this grant.

**SECTION 3.** Upon acceptance of this award, a new fund and internal order number will be created, upon which the sum not to exceed \$654,120.00 will be appropriated from the Office of the Governor, Homeland Security Grants Division. A final and formal budget, which will include Internal Order numbers and General Ledger numbers, will be submitted by the department upon award.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts, as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** In the event of loss or misuse of the SHSP funds, the City assures that the funds will be returned in full.

**SECTION 6.** This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
