ORDINANCE

**AMENDING CHAPTER 19 OF THE CITY CODE TO UPDATE
TRAFFIC CONTROL SCHEDULES OF DEVICES, ADDING 45
LOCATIONS CITYWIDE WHERE NEW INSTALLATIONS OF
TRAFFIC CONTROL DEVICES HAVE OCCURRED, AND
REMOVING 9 LOCATIONS CITYWIDE WHERE DEVICES HAVE
BEEN ALTERED OR REMOVED**

WHEREAS, this ordinance will update various Traffic Control Schedules of Devices established in Chapter 19, Section 68(b) of the City Code of Ordinances; and

WHEREAS, traffic control devices include, but are not limited to, stop signs, traffic signals, parking restrictions, and speed limit designations; and

WHEREAS, this ordinance will enable consistent enforcement of on-street traffic regulations and will further City Council's policy to maintain an efficient and safe flow of traffic; and

WHEREAS, updated traffic control schedules will reflect new installations of traffic control devices and/or the removal of such devices at specified locations; and

WHEREAS, the last update to the Traffic Control Schedule of Devices was enacted on June 22, 2023; and

WHEREAS, the following traffic control devices were added (included) since the previously enacted traffic code update on June 22, 2023:

1. All Way Stops –
(6 additional locations) [Schedule C(a) – update]
2. Cross Street Stop –
(13 additional locations) [Schedule C(b) - update]
3. Cross Street Yield –
(1 additional locations) [Schedule D(a) - update]
4. Maximum Speed Limit –
(2 additional location) [Schedule E(a) – update]
5. Parking Prohibited at All Times, Including Sundays, and Holidays –

(19 additional locations) [Schedule G(a) - update]

6. Stopping, Standing or Parking Prohibited Seven AM to Nine AM and Two PM to Four PM School Days Only –

7. Stopping, Standing or Parking Prohibited Ten PM to Six AM except Sundays and Holidays –

WHEREAS, this ordinance amends the Traffic Control Schedules of Devices for the City of San Antonio, Texas established in Chapter 19, Section 68(b) of the City Code, to add 45 locations where new installations of traffic control devices have occurred, and to remove 9 locations where devices have been altered or removed; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, or the Director of the Public Works Department or designee, is authorized to amend the Traffic Control Schedules of Devices established in Chapter 19, Section 68(b) of the City Code to add 45 locations of new installations of traffic control devices and to remove 9 locations where devices have been altered or removed.

SECTION 2. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
