FIELD NOTES DESCRIPTION

Being a 0.094-acre, (4,088 Square Feet) tract of land out of the remaining 5.00-acres of a called 10.0-acre tract of land, conveyed to Milton Eisenhower, Jr. by deed recorded in Volume 11868, Page 1905, Official Public Records of Bexar County, Texas, N.C.B. 17194, City of San Antonio, Bexar County, Texas, with said 10.0-acre tract being the southeast remaining portion of that certain 100.1-acre Milton Eisenhower tract of land described in Deed of Partition recorded in Volume 4217, Page 186, Deed and Plat Records of Bexar County, Texas. Said 0.094-acre tract being more particularly described as follows, with bearings based on the North American Datum of 1983 (CORS 1996) from the Texas State Plane Coordinate System, Texas South Central Zone (4204):


BEGINNING at a point on the west Right-of-Way line of Bulverde Road and the east line of said 10-acre tract and said 5.00-acre remainder tract, for the southeast corner of this herein described tract, from which a 1-inch iron pipe found within the right-of-way and 25-feet from and perpendicular to the existing west right-of-way line of Bulverde Road, for the shared southeast corner of the original 100.1-acre tract and said 10.0-acre tract, prior to right-of-way dedication recorded in Volume 9513, Pages 125-126, Deed and Plat Records of Bexar County, Texas, bears S 07°29'50" E – 12.00 feet. Said Point of Beginning having state plane coordinate values of, X=2,151,615.27, Y=13,762,246.79.

Thence S 81°28'31" W, a distance of 12.25 feet to a point, for the southwest corner of this herein described tract;

Thence N 08°40'12" W, a distance of 271.97 feet to a point on the north line of said 5.0-acre remainder tract and the south line of a called 5.0-acre tract described in a deed of trust recorded in Volume 15834, Page 369, Official Public Records of Bexar County, Texas, for the northwest corner of this herein described tract;

Thence N 81°34'36" E, along the common line of said 5.0-acre tracts, a distance of 17.82 feet to a point on the west Right-of-Way line of Bulverde Road, the shared corner of said 5.0-acre tracts, for the northeast corner of this herein described tract;

Thence S 07°29'50" E, along the east line of said 5.0-acre remainder tract and the west Right-of-Way line of Bulverde Road, a distance of 271.98 feet to the **POINT OF BEGINNING**, and containing 0.094-acres, (4,088 Square Feet) of land, more or less.

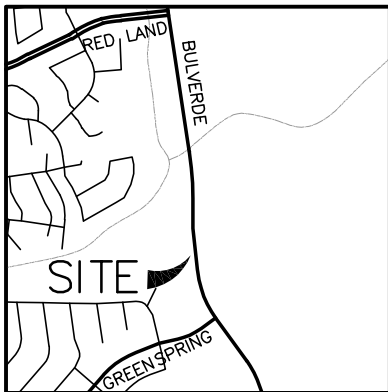

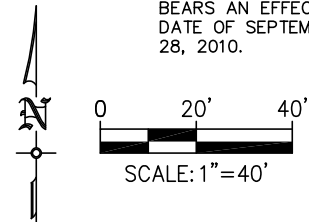

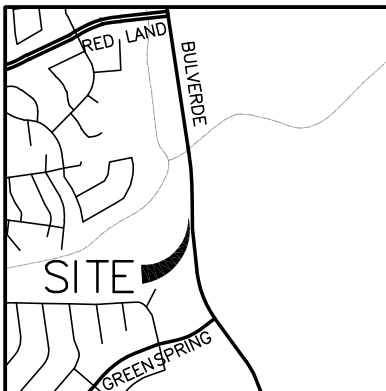

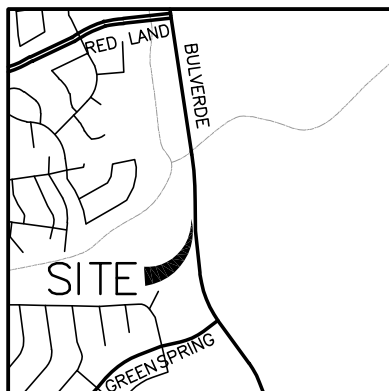
