AN ORDINANCE

APPROVING AN AMENDMENT TO EXTEND A PROFESSIONAL SERVICE AGREEMENT WITH ORACLE TECH DIAGNOSTIC LABS, LLC TO CONTINUE PROVIDING RANDOM, REASONABLE SUSPICION, AND POST-ACCIDENT DRUG TESTING TO SWORN MEMBERS OF THE SAN ANTONIO POLICE DEPARTMENT IN AN AMOUNT OF \$60,000.00 FOR A TOTAL CONTRACT AMOUNT OF \$110,000.00

WHEREAS, the San Antonio Police Department (SAPD) conducts random, post-accident and reasonable suspicion drug testing pursuant to the terms of their collective bargaining agreement; and

WHEREAS, SAPD entered into an emergency contract in April 2024 with Oracle Tech Diagnostic Labs, LLC. to provide the testing services; and

WHEREAS, SAPD now wishes to amend the agreement to provide sufficient funding to allow for continuation of testing services; and

WHEREAS, said agreement provides for continuation of service on a month-to-month basis until completion of the pending solicitation and award of the new contract; and

WHEREAS, the total estimated cost of this agreement is \$110,000.00; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City's contract with Oracle Tech Diagnostic Labs, LLC. is hereby amended to allow for continuation of services on a month-to-month basis from October 15, 2024 through April 30, 2025. City Manager or designee is hereby authorized to execute the Amendment. The terms of the Amendment are hereby approved.

SECTION 2. Funding for this amendment in the amount of \$60,000.00 for this ordinance is available in Fund 11001000, Cost Center 1701010006 and General Ledger 5201040 as part of the Fiscal Year 2025 Adopted Budget approved by City Council.

SECTION 3. Payment for this additional amount of \$60,000.00 is authorized to Oracle Tech Diagnostic Labs, LLC (Oracle) and should be encumbered with a purchase order.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager’s designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance becomes effective immediately if passed and approved by eight (8) affirmative votes; otherwise this Ordinance shall take effect ten (10) days from the date of passage.
