SUMMARY:

The Human Resources Department is recommending the reappointment of one current Firefighters and Police Officers Civil Service Commissioner. As such, we request the Clerk's Office include the appointment on the next available City Council agenda for consideration and action.

BACKGROUND:

Established by Texas Local Government Code (Chapter 143). The purpose of the Firefighters and Police Officers Civil Service Commission is to assist with securing fire and police department personnel who are free from political influence and who have met public servant employment requirements as set forth by Chapter 143. The Commission develops, adopts and enforces rules necessary to carry out the intent of the law. The Commission generally meets on the second Monday of every month, with meetings typically lasting 1 – 2 hours. The Commission consists of three regular members appointed by the City Manager and confirmed by City Council for staggered three-year terms.
