Councilmember McKee-Rodriguez expressed concern that too much industrial development in District 2 had resulted in fewer opportunities for housing and businesses that supported residents like grocery stores.

Councilmember McKee-Rodriguez moved to amend Item 28 to only approve for C-2

Commercial District zoning. Councilmember Cabello Havrda seconded the motion.

The applicant's representative Ken Brown requested to speak on the zoning case. Mayor Nirenberg recognized Brown to speak. Brown recommended not taking action on the Item and requested a continuance to October 31, 2024.

Councilmember Viagran commented that this was a problematic case and was concerned with the lack of geographically diverse representation on the Planning Commission that she had previously expressed with her Council Consideration Request (CCR) 2024-0019.

Councilmember McKee-Rodriguez explained that he decided to move the Item forward to benefit the residents without telling the applicant his intent to amend the zoning because the item would just keep being continued with no real benefit to the community.

Mayor Nirenberg asked Brown if the applicant desired to withdraw the application. Brown said that if he had known Councilmember McKee-Rodriguez was not going to support the zoning with conditional use, he would have withdrawn the applicant's request.

Mayor Nirenberg requested a presentation to explain the project. Assistant Planning Director Rudy Nino provided a map of the project and site plan and explained that a portion of the project abutting IH 10 was within the San Antonio City limits and a portion was outside the City limits. Nino provided a timeline of the case and breakdown of the actions. Nino said staff recommended approval of the annexation and the zoning with conditional use that would allow for a large trucking sales and storage on site and Councilmember McKee-Rodriguez' amendment would remove the requested conditional use.

Councilmember Courage moved to continue Items 26, 27, and 28 to October 31, 2024 to collect more information. Mayor Nirenberg seconded the motion.

Councilmember Viagran said she supported the continuance because of her concerns about the Planning Commission.

Councilmember Whyte did not support the motion to continue but did not like the way the amendment to Item 28 was brought forward without communication with the applicant.

Councilmember McKee-Rodriguez agreed this was not the most transparent way to go about the case but did not want to continue to discuss the case because the use was inconsistent with what the neighborhood wanted.

Councilmember Courage asked Brown if the property became part of the City but did not have the zone requested by the property owner would they propose a different use. Brown said he was only working on the currently proposed use. Councilmember Courage said he respected the neighbors' position but was concerned that the property owner had

requested annexation for a specific use only to have Council to switch the use intended by the owner. Therefore, he wanted to let the property owner withdraw his request for annexation. Brown requested to withdraw the application.

Mayor Nirenberg supported the continuance so that the Council could get a better understanding and called for a vote on the continuance. Motion to continue Items 26, 27, and 28 to October 31, 2024 failed by the following vote: Aye (5) Viagran, Cabello Havrda, Alderete Gavito, Courage, and Nirenberg. Noes (2) McKee-Rodriguez and Whyte. Councilmembers Kaur, Rocha Garcia, and Castillo abstained. Six affirmative votes are required for a vote to pass, thus the motion failed.

Councilmember Cabello Havrda asked for procedural clarification. Segovia clarified that Item 28 should be considered first, then, Items 26 and 27 because the annexation would be moot if the zoning on Item 28 was not approved.

Councilmember Rocha Garcia asked how long the case had been underway. Nino said the case had been in process for five months.

Councilmember Kaur cited the need for more information and moved to continue the Item to November 7, 2024. Councilmember Courage seconded the motion.

Councilmember McKee-Rodriguez noted that any development on this property would trigger the annexation agreement.

Councilmember Cabello Havrda called for the orders of the day. City Attorney Segovia explained that the point of order would mean that the Council would need to take up the vote on Items 26, 27, and 28 in the order posted on the agenda.

Mayor Nirenberg called for a vote on the motion to Continue Items 26, 27, and 28 to November 7, 2024. Motion carried and all other pending motions fell to the floor.

Councilmember Kaur moved to Continue to November 7, 2024. Councilmember Courage seconded the motion The motion prevailed by the following vote:
