### FIELD NOTE DESCRIPTION

Variable Width Temporary Construction Easement  
0.0049 of One Acre of Land (213 sq. ft.)

Being a 0.0049 acre (213 square feet) tract of land, situated in San Antonio, Bexar County, Texas; and being out of a 0.9625 acre remaining portion of a called 244.5 acre tract as conveyed to D., J., R., & G. Pape and recorded in Volume 18375, Page 321, Official Public Records of Bexar County, Texas; said 0.0049 acres being more particularly described by metes and bounds as follows with all bearings being referenced to the North American Datum 1983, Texas Coordinate System, South Central Zone:

**Beginning**, at a found 1/2-inch iron rod for the Northwestern corner of said 0.9625 acres and being on the proposed Southerly right-of-way line of Classen Road (variable width R.O.W.);

**Thence**, S 51° 51' 48" E, 10.01 feet, to a found 1/2-inch iron rod for the Northeasterly corner of said 0.9625 acre tract for the Northeasterly corner of the herein described tract;

**Thence**, S 06° 18' 44" E, 19.93 feet, to a point for the Southeasterly corner of the herein described tract;

**Thence**, N 45° 58' 20" W, 24.32 feet, to a point for the Southwesterly corner of the herein described tract;


**Thence**, N 39° 14' 20" E, 11.73 feet, to the **Point of Beginning**, containing 0.0049 acres (213 square feet) of land, more or less.

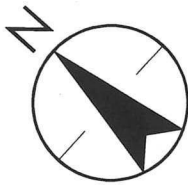
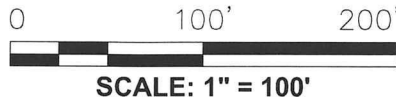
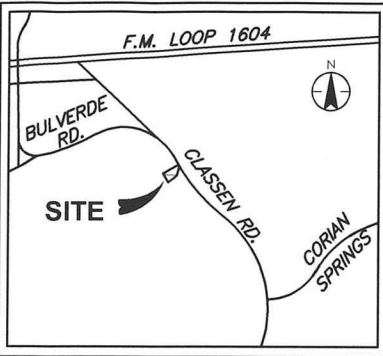

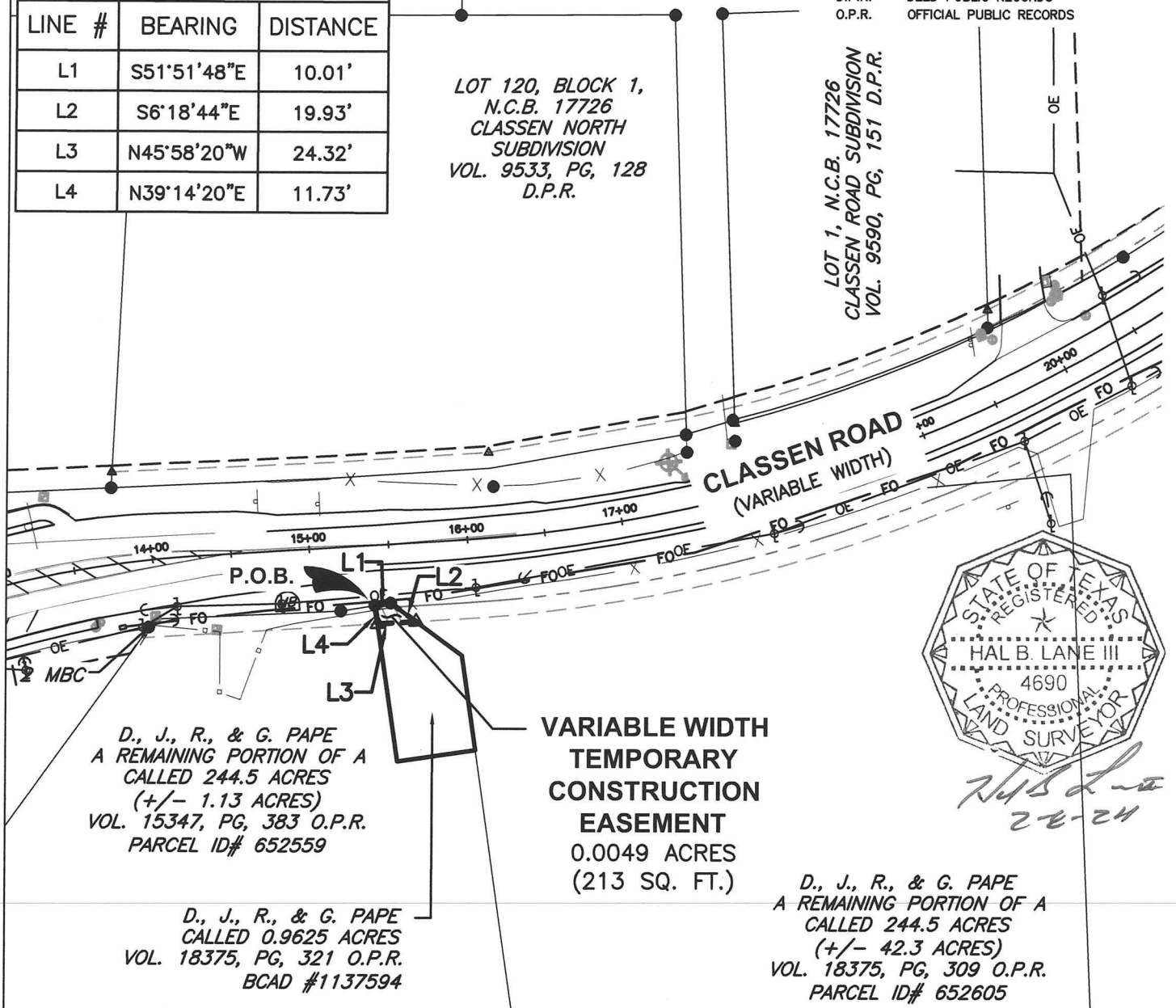
