**METES AND BOUNDS DESCRIPTION**

**A 0.833 OF AN ACRE TRACT (36290 SQ. FT.), BEING LOT 60, BLOCK E, NEW CITY BLOCK 11543, WOODLAWN HILLS, ACCORDING TO THE PLAT THEREOF RECORDED IN VOLUME 980, PAGE 189-190, DEED AND PLAT RECORDS OF BEXAR COUNTY, TEXAS, SAVE AND EXCEPT THAT PORTION OF LOT 60, BLOCK E DESCRIBED AS A 24908 SQUARE FOOT TRACT IN A DEED TO THE CITY OF SAN ANTONIO, RECORDED IN VOLUME 5385, PAGE 408, REAL PROPERTY RECORDS OF BEXAR COUNTY, TEXAS; SAID 0.833 ACRE TRACT BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:**

**BEGINNING** at a 1/2 inch iron rod found in the west right-of-way line of Parkway Drive (60' R.O.W.) at the southeast corner of LOT 60, being the northeast corner of LOT 59, BLOCK E of said WOODLAWN HILLS, for the southeast corner hereof;

**THENCE South 72° 45' 55" West** with the south line of LOT 60, being the north line of LOT 59, BLOCK E of said WOODLAWN HILLS, passing at a distance of 341.53 feet a 1/2 inch iron rod found online, and continuing for a total distance of **343.32 feet** (South 73° 32' West, record plat), to a 1/2 inch iron rod set in the easterly boundary line of San Antonio 24908 sq. ft. tract, for the southwest corner hereof;

**THENCE** leaving the south line and crossing through of LOT 60, BLOCK E of said WOODLAWN HILLS, with the southerly boundary line of the San Antonio 24908 sq. ft. tract, the following three (3) courses and distances:

1. **North 08° 28' 05" West** a distance of **13.21 feet** (North 08° 53' 49" West, record deed), to a 1/2 inch iron rod found, with plastic cap marked "NORTHSTAR RPLS 4350", for the point of curvature hereof;
2. With the arc of a curve to the right with **Radius** of **120.50 feet** (120.50 feet, record deed), **Central Angle** of **82° 28' 27"** (82° 28' 22", record deed), an **Arc length** of **7.56 feet** (7.53 feet, record deed), and a Chord that bears **South 00° 26' 11" East** a distance of **173.45 feet** (173.45 feet, record deed), and a **Chord** that bears **North 32° 21' 23" East** a distance of **158.86 feet** to a 1/2 inch iron rod found, with plastic cap marked "NORTHSTAR RPLS 4350", for the point of tangency hereof;
3. **North 73° 36' 00" East** a distance of **220.42 feet** (North 73° 34' 28" East, 220.28 feet, deed record) to a 1/2 inch iron rod found, with plastic cap marked "NORTHSTAR RPLS 4350", in the east line of said LOT 60, being the west right-of-way line of Parkway Drive, at the southeast corner of the San Antonio 24908 sq. ft. tract, for the northeast corner hereof;

**THENCE South 17° 12' 17" East** a distance of **112.82 feet** (South 16° 28' East, 112.77 feet, record deed) with the east line of LOT 60, BLOCK E of said WOODLAWN HILLS, being also the west right-of-way line of Parkway Drive, to the **POINT OF BEGINNING**, containing 0.833 of an acre (36290 sq. ft.);

Basis of Bearing: Texas South Central NAD 83  
All 1/2 inch iron rods set are capped with "AmeriSurveyors" cap.
