ORDINANCE

APPROVING A CONTRACT WITH PUMP SOLUTIONS, INC., TO PROVIDE THE PUBLIC WORKS DEPARTMENT WITH TWO NEW SUBMERSIBLE PUMPS, ASSOCIATED MONITORS AND PANELS FOR A TOTAL COST OF \$270,750.00. FUNDING IS FROM THE STORMWATER OPERATING FUND.

WHEREAS, bids were submitted to provide the City of San Antonio, Public Works Department with two replacement submersible pumps, associated monitors and panels, which will be utilized at the San Antonio River Tunnel Outlet Facility; and

WHEREAS, the pumps are crucial for aerating the recirculated water to improve water quality going into the tunnel and prevent flooding to the facility. The pumps support river and flood control and will be installed by the Public Works Department; and

WHEREAS, the bid submitted by Wastewater Solutions, LLC, failed to meet the City's specifications and/or requirements for replacement submersible pumps, associated monitors and panels; and

WHEREAS, Pump Solutions, Inc., submitted the lowest responsive bid for a total cost of \$270,750.00; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The bid submitted by Pump Solutions, Inc., for a total cost of \$270,750.00, is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation is attached hereto and incorporated herein for all purposes as **Exhibit I**.

SECTION 2. It has been found and declared that the bid submitted by Wastewater Solutions, LLC, failed to meet the City's specifications and/or requirements for replacement submersible pumps, associated monitors and panels.

SECTION 3. Funding for this ordinance in the amount of \$270,750.00 is available in Fund 29070000, Cost Center 2304050001 and General Ledger 5501055 as part of the Fiscal Year 2024 Adopted Budget approved by City Council.

SECTION 4. Payment in the amount of \$270,750.00 is authorized to Pump Solutions, Inc., and should be encumbered with a purchase order.

SECTION 5. The financial allocations in this ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 6. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
