

ORDINANCE

APPROVING TWO PROFESSIONAL SERVICES AGREEMENTS FOR ON-CALL ENVIRONMENTAL COMPLIANCE, SUSTAINABILITY INITIATIVES AND ENGINEERING CONSULTING SERVICES WITH RS&H, INC. AND WESTON SOLUTIONS, INC., EACH IN AN AMOUNT NOT TO EXCEED \$1,000,000.00 AT SAN ANTONIO INTERNATIONAL AIRPORT AND STINSON MUNICIPAL AIRPORT.

WHEREAS, on-call consulting services firms are able to provide the Aviation Department with a team that can provide timely access to comprehensive environmental compliance, sustainability initiatives and engineering consulting services required to comply with the regulations set forth by the Texas Commission for Environmental Quality and the U.S. Environmental Protection Agency; and

WHEREAS, City released a Request for Qualifications (RFQ) for “On-Call Environmental Consulting Services for San Antonio Airport System” on October 8, 2024, and received nine proposals by the December 6, 2024, deadline, of which one was deemed non-responsive; and

WHEREAS, an evaluation committee consisting of representatives from representatives from the Aviation Department and CPS Energy met on February 3, 2025, and based on the published criteria, three firms were short-listed to be interviewed; and

WHEREAS, the three short listed firms were interviewed and scored on March 11, 2025, and the committee recommends awarding contracts to RS&H, Inc. and Weston Solutions, Inc.; and

WHEREAS, this Ordinance authorizes the execution of professional services agreements with RS&H, Inc. and Weston Solutions, Inc. each in an amount not to exceed \$1,000,000.00 for Airfield Engineering Design Services for On-Call General Engineering Consulting Services; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee is authorized to execute professional services agreements with RS&H, Inc. and Weston Solutions, Inc. each in an amount not to exceed \$1,000,000.00 for on-call environmental compliance, sustainability initiatives and engineering consulting services at San Antonio International Airport and Stinson Municipal Airport, copies of which are set out in **Exhibit 1**.

SECTION 2. Funding in the amount of \$1,000,000.00 for this ordinance is available in Fund 51001000, Cost Center 3305030004 and General Ledger 5201040 as part of the Fiscal Year 2025 Adopted Budget approved by City Council.

SECTION 3. Additional funding is contingent upon City Council approval of the Fiscal Year 2026 and subsequent budgets that fall within the contract terms of this ordinance.

SECTION 4. Payment in the amount up to \$5,000,000.00 is authorized to RS&H, Inc. and Weston Solutions, Inc. and should be encumbered with a purchase order.

SECTION 5. The financial allocations in this Ordinance are subject to approval by the Chief Financial Officer, City of San Antonio. The Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager’s designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 6. This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
