

FIELD NOTE DESCRIPTION

Variable Width Right-of-Way Acquisition (fee simple)
0.3297 of One Acre of Land (14,364 sq. ft.)

Being a 0.3297 acre (14,364 square feet) tract of land, situated in San Antonio, Bexar County, Texas; and being out of a +/- 76.4 acre remaining portion of a called 244.5 acre tract as conveyed to D., J., R., & G. Pape and recorded in Volume 18375, Page 309, Official Public Records of Bexar County, Texas; said 0.3297 acres being more particularly described by metes and bounds as follows with all bearings being referenced to the North American Datum 1983, Texas Coordinate System, South Central Zone:

Beginning, at a set 1/2-inch iron rod with Stantec Cap on the Northwesterly line of said 78.82 acre remaining portion and being on the Southerly right-of-way line of Classen Road (variable width R.O.W.), from which the North most corner of said 78.82 acre remaining portion bears N 47° 52' 10" W, 28.42 feet;

Thence, along the Southerly right-of-way line of said Classen Road as follows:

- N 47° 52' 10" W, 28.42 feet, to a point for the North most corner of the herein described tract;
- Along the arc of a curve to the left, having a chord of S 71° 29' 31" E, 269.06 feet, a radius of 985.37 feet and a central angle of 15° 41' 38", an arc distance of 269.90 feet, to a point of tangency for corner;
- S 79° 20' 28" E, 130.81 feet, to a point of curvature for corner;
- Along the arc of a curve to the right, having a chord of S 61° 50' 29" E, 556.52 feet, a radius of 925.37 feet and a central angle of 34° 59' 59", a distance of 565.27 feet, to a point of tangency for corner;
- S 44° 21' 13" E, 150.67 feet, to a point for the Southeasterly corner of the herein described tract;

Thence, S 49° 30' 14" W, 12.18 feet, to a set 1/2-inch iron rod with Stantec Cap for the Southwesterly corner of the herein described tract;

Thence, crossing said 74.6 acre remainder as follows:

- N 45° 30' 09" W, 136.50 feet, to a set 1/2-inch iron rod with Stantec Cap at a point of curvature for corner;

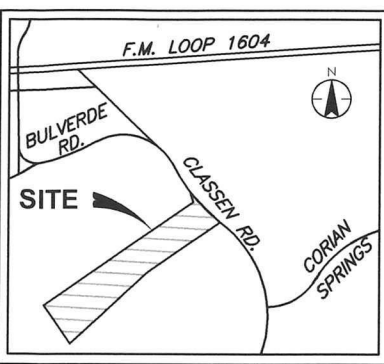
- Along the arc of a curve to the left, having a chord of N 62° 02' 43" W, 600.92 feet, a radius of 1055.25 feet and a central angle of 33° 05' 07", a distance of 609.35 feet, to a set 1/2-inch iron rod with Stantec Cap at a point of tangency for corner;
- N 78° 35' 16" W, 105.66 feet, to a set 1/2-inch iron rod with Stantec Cap at a point of curvature for corner;
- Along the arc of a curve to the right, having a chord of N 72° 02' 20" W, 228.76 feet, a radius of 989.77 feet and a central angle of 13° 16' 20", a distance of 229.27 feet, to the **Point of Beginning**, containing 0.3297 acres (14,364 square feet) of land, more or less.

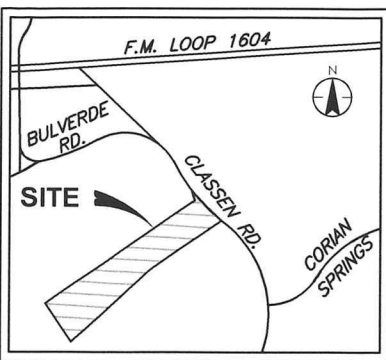

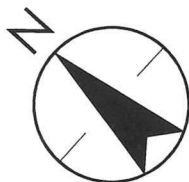

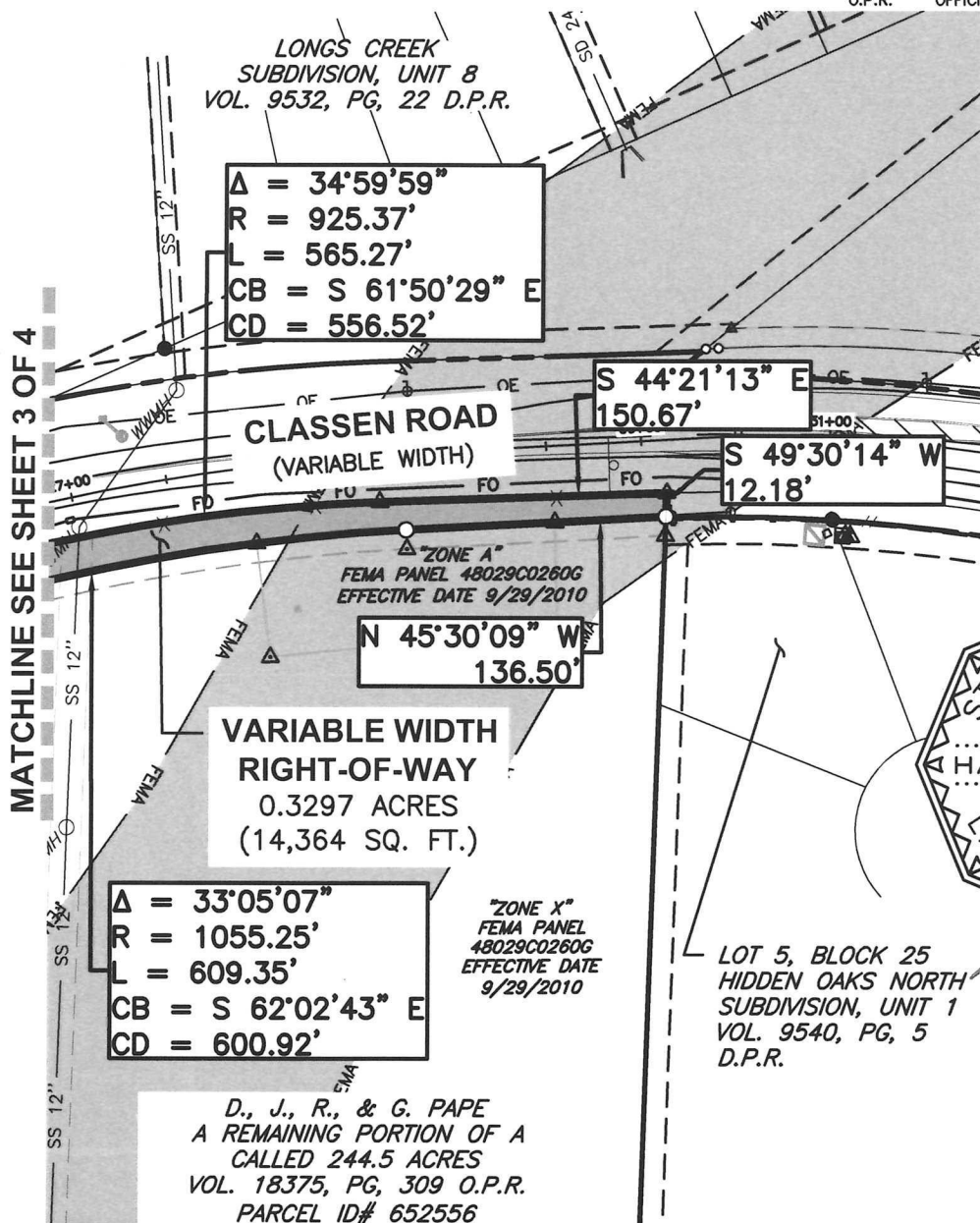
