IT IS FURTHER ORDERED, ADJUDGED AND DECREED that all relief sought herein which is not expressly granted is denied.

This Agreed Final Judgment disposes of all claims, counterclaims, and causes of action by and between the parties in this suit and is the final, appealable Judgment in this cause.
