


Summary



- An ordinance awarding nineteen (19) qualified construction contractor firms to be utilized for rehabilitation of various residential properties.
- The City assists low-to-moderate income families with rehabilitation services (Major Rehab, Minor Rehab including roof shingle replacement) to address health, safety and code concerns.
 - Bond funded projects will prioritize families at **50% AMI or below**.
- Homeowners apply through Home Rehab Application and selected using an **Equity Scoring Matrix** prioritizing lower AMI levels, older adults, families with disabilities and homeowners with longer length of ownership.
- With these awards, NHSD will create a list of qualified contractors for upcoming 2022-2027 Housing Bond projects.

Fiscal Impact



- The term of the contract is one (1) year with the option for four (4), one (1) year renewals for an estimated total value up to \$45,000,000.

Recommendation

- Staff recommends selection of nineteen (19) qualified construction contractor firms for rehabilitation of various residential properties funded by the 2022-2027 Housing Bond Program and General Fund in the FY 23 Adopted.
- Contracts have an estimated total value up to \$45,000,000 for a 1-year term with 4, 1-year options to renew for a total of 5 years.
