ORDINANCE

APPROVING THE EXECUTION OF AN AMENDMENT IN THE INCREASED AMOUNT OF \$433,508.14 FOR A TOTAL AMOUNT OF \$1,481,904.07 TO THE PROFESSIONAL SERVICES AGREEMENT WITH LEGACY ENGINEERING GROUP, PLLC FOR ADDITIONAL CIVIL ENGINEERING SERVICES FOR THE BABCOCK ROAD (WEST HAUSMAN TO UTSA BOULEVARD) PROJECT, LOCATED IN COUNCIL DISTRICT 8. FUNDS ARE AVAILABLE FROM 2022 GENERAL OBLIGATION BOND FUNDS INCLUDED IN THE FY 2024 - FY 2029 CAPITAL IMPROVEMENT PROGRAM.

WHEREAS, on November 10, 2022, through Ordinance 2022-11-10-0872, City Council approved a professional services agreement with Legacy Engineering Group, PLLC, in the amount of \$1,048,395.93 for civil engineering services for the voter approved 2022 Bond Program Babcock Road (West Hausman to UTSA Boulevard) Project located in Council District 8; and

WHEREAS, the Babcock Road (West Hausman to UTSA Boulevard) Project reconstruct and widen Babcock Road from West Hausman to UTSA Boulevard, including new sidewalks, curbs, driveway approaches, drainage, and pedestrian lighting along a park path. The project is currently under design, and design completion is anticipated in Summer 2024; and

WHEREAS, During the design process, design review processes identified changes to the drainage design that significantly reduced the anticipated construction cost by reducing the need to construct significant underground drainage. These savings allow for extension of the project's limits and provide additional enhancements at each of the intersections to further improve the traffic flow in the subject area; and

WHEREAS, the proposed amendment will increase the agreement capacity by \$433,508.14 for a revised agreement amount of \$1,481,904.07. This will be the first amendment to this agreement.

This amendment authorizes and compensates Legacy Engineering Group, PLLC, for additional civil engineering services related to the Babcock Road (West Hausman to UTSA) Project; and

WHEREAS, this Ordinance approves the execution of an amendment in the increased amount of \$433,508.14, for a total Design Services Agreement amount of \$1,481,904.07 with Legacy Engineering Group, PLLC, for additional civil engineering services for the Babcock Road (West Hausman to UTSA Boulevard) Project. Funds are available from 2022 General Obligation Bond funds included in the FY 2024 - FY 2029 Capital Improvement Program; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or designee, or the Director of the Public Works Department or designee, is authorized to execute an amendment in the increased amount of \$433,508.14, for a total Design Services Agreement amount of \$1,481,904.07 with Legacy Engineering Group, PLLC, for additional civil engineering services for the Babcock Road (West Hausman to UTSA Boulevard) Project.

SECTION 2. Funds for this contract amendment in the increased amount of \$433,508.14 is available in Fund 45099000, Project 23-03865, WBS Element 23-03865-01-02-01 and GL Account 5201170. Funding is provided by General Obligation bond funds and is included the FY 2024 - FY 2029 CIP Budget.

SECTION 3. Additional payment from this contract amendment not to exceed \$433,508.14 is authorized to be encumbered with a purchase order and made payable to Legacy Engineering Group, PLLC for additional engineering services.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer, City of San Antonio. The Deputy Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Fund Numbers, Project Definitions, WBS Elements, Internal Orders, Fund Centers, Cost Centers, Functional Areas, Funds Reservation Document Numbers, and GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
